The City was sent a "Notice to Comply" letter regarding leaking fuel tanks at 11759 Dublin Blvd. I just received the letter today and am in process of pulling the data together. I did have one question. It states that I need to provide reports from July 1 2005 on. The abandoned tanks were uncovered as part of a demo project and based on historical information it appears that they were buried some time in the late 50's early 60's. When they were found we had a full analysis run of the tanks and surrounding soil and did sampling during removal. This is what I plan to add to the Geo tracker site.

Steve Plunkett is the contact person but he is on vacation until July 14th and the upload is due by the 10th. Can you let me know if that works?
