Thanks for the message.

Regarding the additional items you need, we are working on preparing an agenda, and will send that to you shortly. I know Faye's team is working on the list of requirements for the letter. Details on proposed engineering controls will also be provided with the agenda.

Regarding the impacted soil that remains in place, as we indicated in our report, most of the mass has been removed, and there aren't significant impacts to groundwater in the vicinity of the impacted soil. Additionally, we expect that engineering controls will be necessary throughout some of the planned development anyway. As a result, we believe it is protective of human health and groundwater quality, and also most cost-effective, to just install engineering controls (if residential or commercial buildings are to be built in the area of the impacted soil).
