Hi David.

Normally I wouldn't think we would need to approve a simple well resampling, but to document it to the USTCF that we are in concurrence with your thinking, and to request that the wells be fully redeveloped due to their long disuse (too much chance for the sediment load to confuse the analytical results for groundwater), to measure the total well depths, and to request submittal of the data and interpretations in a report. That could be in a groundwater monitoring report and work plan (or something along those lines). It would definitely be useful information for the site. And I suppose you could now use this email as ACEH concurrence with your thinking! If you do proceed, let me know a couple days ahead. I'm not sure I'll be out, but it might work out. Did I forget something?
