As I mentioned, several families living very close to this property have young children and are concerned about the soil removals that have been taking place since March of this year, and the soil that has been blowing into our homes that smells of petroleum. We have attempted to stop it by calling Bay Area Air Quality Management and the Fire Department, but to no avail. I realize your department may not be able to do anything about what has happened already, but we do want know what we have breathed and how to stop this from reoccurring. We also hope that you and your department will do everything in your power to ensure that any further soil removals will only occur under very controlled circumstances, such as erecting an enclosed tent around the site to prevent contaminated soil from blowing over and possibly affecting the developing lungs and brains of our children. Other neighbors on the downhill side of the property are concerned how any groundwater contamination affects their properties (vegetable gardens and the like.)
