I understand that you have now been able to access the numerous technical reports available to the public on Alameda County's ftp site and that your main concern with closing this case is that there is insufficient remediation of groundwater contamination. To address this concern, please review Table 1, *Groundwater Analytical Results*, in the document called "GWM_R_2014-03-25", the *First Quarter 2014 Groundwater Monitoring Report*. This report is the most recent groundwater monitoring report and the table contains all historic site groundwater analytical data. The three site groundwater monitoring wells have been consistently sampled for water quality for seven quarters. This data indicates that remedial efforts at the site were successful, the site meets the State Water Resources Control Boards (SWRCBs) Low Threat Closure Policy (LTCP), and the case should be closed.
