Attached you should find the San Mateo County list of consultants they have found qualified to conduct environmental investigations. Be aware that you will find differences in cost based on the size of the company, larger or smaller overheads (and remember it's a bit dated, but still the most recent). One thing I forgot to mention was that the UST Cleanup Fund requires bids from three consultants, and typically requires use of the lowest cost estimate. So it is useful to discuss a scope of work with a couple consultants, and then request cost estimates based on that specific scope of work (to allow an apple to apple comparison, or better yet Gravenstein apples to Gravenstein apples comparison).

I've also attached our directive letter so that the electronic links are quickly available for your use. If acceptable I'll use this email for future letters, unless you prefer us to use another email address. This speeds delivery, cuts postage, and makes the electronic links available for quick use.
