Hi Megan,

The heating oil exemption is from regulatory compliance regulations used to ensure tanks do not leak, such as at service stations (continuous leak detection monitoring, yearly testing, yearly permitting, etc). These actions are intended to prevent releases. It does not apply to regulatory environmental oversight from the release of contamination. Once contamination is released an investigation is warranted. For this particular case, ACEH generally believes that limited additional work is needed to reach closure and does not expect the work to be very intrusive.

Once source of confusion may be that the compliance group (known by its acronym - CUPA) closed the task removal portion of the case; but with documentation of contamination an environmental case was opened in the group I work with (the LOP group). It is the environmental case we are trying to get closed in this situation.

We do have a copy of the tank report. Should you want to determine we have everything, please use the link below my name to access the ACEH website that contains all documents associated with this case. You'll need to work through several screens and drop down menus. Make sure you are not in the "Restaurant Inspection" result box, but are in the LOP Records box. I usually use the case number (RO0003070), but there are several choices. Hope this helps.

Megan and Ms. Mulholland,

Thanks for the email. I understand your concerns. We generally have found that meetings help move a site to a closure stage more quickly, so the intent is to bring interested parties together, focus the discussions, and hopefully obtain a consensus. For this particular case, hopefully less than 90 minutes will be needed, but we generally schedule 2 hours. As you have guessed, the intent is to "walk" the site through the LTCP together; that is the limit of the agenda. Existing data indicates that the site does not appear to meet the groundwater specific criteria of the LTCP; however, the discussions may shed additional light on the available data. Because the meeting will be limited to a technical discussion of the LTCP, Ms. Mulholland may want her consultant to attend.
