#### Dear Mr. Macedo:

Alameda County Environmental Health (ACEH) is reviewing the fuel case file for the above referenced site for potential case closure. Site investigation and groundwater monitoring from underground storage tank leaks have been performed at the subject property to which you are named as the primary or active responsible party. Pursuant to Section 25297.15 (a), ACEH, the local agency, shall not consider cleanup or site closure proposals from the primary or active responsible party, issue a closure letter, or make a determination that no further action is required with respect to a site upon which there was an unauthorized release of hazardous substances from an underground storage tank subject to this chapter unless all current record owners of fee title to the site of the proposed action have been notified of the proposed action by the primary or active responsible party. ACEH is required to notify the primary or active responsible party of their requirement to certify in writing to the local agency that the notification requirement in the above-mentioned regulation has been satisfied and to provide the local agency with a complete mailing list of all record fee title owners.

To satisfy the above-mentioned requirement, please complete the enclosed "List of Landowners Form," and mail it back to ACEH within thirty (30) days from the date of this letter. To confirm that you are the sole responsible party and current landowner, please enter your name in item 2 and sign the form at the bottom. Also your comments must be considered prior to the proposed cleanup or closure. Please respond within 30 days from the date of this letter for your comments to be considered.

Public participation is a requirement for the Corrective Action Plan and case closure process. In order to notify potentially affected members of the public of the potential fuel leak case closure, we request that you distribute the attached Notification of Potential Case Closure to the addresses shown on the two attached mailing lists as well as all parties listed on the cc list to this correspondence **no later than October 7, 2011**. Please ignore duplicate or repeated addresses on the mailing. Some property owners may be listed more than once on the mailing; however, only one notification to each address is required. The Notification of Potential Case Closure requests that landowners or residents submit any comments or questions to ACEH regarding potential case closure by November 5, 2011. Following distribution by U.S. Mail to the attached mailing list, please submit written verification of the date that the Notification of Potential Case Closure was distributed. ACEH will consider all comments from the public prior to potential case closure.

# NOTIFICATION OF POTENTIAL CASE CLOSURE GENO COUNTRY STORE

October 6, 2011

## Site Location: 1000 North Vasco Road, Livermore, CA 94551 Fuel Leak Case RO0003073 and GeoTracker Global ID T10000002919

**Summary** – This fact sheet has been prepared to inform community members and other interested parties of potential case closure for a fuel leak case at a former gasoline and diesel fuel service station at 1000 North Vasco Road in Livermore, California (see attached map on back). The site currently consists of a restaurant, two commercial businesses, a former car wash, and 1.87 acres of open land abutting Central Avenue. Future plans for the site include demolition of the existing structures and construction of single-family homes and a park.

There have been two fuel leak cases at the site. During underground storage tank (UST) removal activities in October 1994, fuel leaks were discovered in two areas of the site. Following completion of site investigation activities and excavation of approximately 600 cubic yards of soil, this initial fuel leak case was closed on May 22, 2000. In July 2008, fueling operations were stopped at the facility.


In January 2011, the remaining two gasoline USTs and one diesel UST along with associated piping and dispensers were removed. Based on the detection of total petroleum hydrocarbons (TPH) as diesel in soil and groundwater samples collected during the tank removals, a fuel leak case was opened in March 2011. Site investigation activities that included soil, soil vapor, and groundwater sampling were conducted between April 2011 and August 2011 to define the extent of contamination. The investigations showed several areas of shallow soil impacted by petroleum hydrocarbons in areas of the former USTs and dispensers. The soil contamination was primarily TPH as diesel with lesser concentrations of TPH as gasoline and motor oil.

In August 2011, soil excavation was undertaken in five areas of the former USTs, piping, and dispensers to remove residual soil contamination. Approximately 1,258 tons of contaminated soil from the five areas was disposed off-site at the Republic Services Vasco Road Landfill in Livermore, CA. A second phase of excavation was undertaken in September 2011 to remove aggregate fill material that contained TPH as diesel and TPH as motor oil.

The extent of groundwater contamination appears to be limited to the areas of the former USTs and dispensers. Dissolved petroleum hydrocarbons in groundwater within the limited area are expected to naturally biodegrade within a reasonable period of time. Site investigation and cleanup activities have been completed and it does not appear that the fuel release presents a risk to human health for current users or future residents of the site. Therefore, ACEH is considering potential closure of the fuel leak case.

**Next Step** – The public is invited to review and comment on the potential closure of the fuel leak case.
