Alameda County Environmental Health (ACEH) staff has reviewed the case file for the above-referenced site including the recently submitted document entitled, "Additional Site Investigation Report, Former Waste Management Facility, 6175 Southfront Road, Livermore, California," dated February 15, 2012 (Report). The Report, which was prepared on behalf of Waste Management of Alameda County, Inc. by Tetra Tech Geo, presents results from soil vapor, soil, and groundwater sampling.

Numerous volatile organic compounds were detected in soil vapor samples collected in the area of previous sample location SV-6. Vinyl chloride was detected in soil vapor at concentrations up to 17,000 micrograms per cubic meter (µg/m³). We request that you address the following technical comments, perform the proposed work, and send us the Work Plan described below

TECHNICAL COMMENTS

- 1. **Vinyl Chloride in Soil Vapor.** Vinyl chloride was detected at concentrations of 730 and 17,000 µg/m³ in the two soil vapor samples collected in the area of previous soil vapor sample SV-6. These concentrations significantly exceed the Environmental Screening Level for commercial land use of 100 µg/m³. The highest concentration of vinyl chloride was detected in soil vapor sample SV-14, which is located adjacent to the Break Room/Offices shown on Figure 1 of the Report. We request that you conduct additional investigation to evaluate the potential for vapor intrusion to the Break Room/Offices. This includes additional sampling and discussion of the current and projected future use of the building.
- Source of Vinyl Chloride in Soil Vapor. The source of vinyl chloride in soil vapor is not known. We request that you conduct additional investigation to find the source of vinyl chloride. This includes identification of potential discharge locations such as sewer lines, sumps, or other similar features.

3. Groundwater Sampling Methods. The "Work Plan for Additional Investigation, Former Waste Management Facility, 6175 Southfront Road, Livermore, California," dated September 7, 2011 proposed that the soil borings would be advanced to a depth of approximately 20 feet bgs to collect grab groundwater samples. Borings SB-1 through SB-3 were actually advanced to a depth of 35 feet bgs where groundwater rose up in the borings to depths as shallow as 10 feet bgs. We do not concur with advancing the borings to these depths to collect groundwater samples. The groundwater entering the borings is likely from a deeper zone and does not provide representative data on shallow contamination that may be present above 20 feet bgs. We also do not concur with using these data to draw the conclusions stated in the Report regarding the absence of groundwater contamination at the site. We request that you present plans in the Work Plan requested below to collect groundwater samples from the depths at which shallow contamination may be present.

REPORT REQUESTS

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.

ELECTRONIC SUBMITTAL OF REPORTS

ACEH's Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of reports in electronic form. The electronic copy replaces paper copies and is expected to be used for all public information requests, regulatory review, and compliance/enforcement activities. Instructions for submission of electronic documents to the Alameda County Environmental Cleanup Oversight Program FTP site are provided on the attached "Electronic Report Upload Instructions." Submission of reports to the Alameda County FTP site is an addition to existing requirements for electronic submittal of information to the State Water Resources Control Board (SWRCB) GeoTracker website. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs. For several years, responsible parties for cleanup of leaks from underground storage tanks (USTs) have been required to submit groundwater analytical data, surveyed locations of monitoring wells, and other data to the GeoTracker database over the Internet. Beginning July 1, 2005, these same reporting requirements were added to Spills, Leaks, Investigations, and Cleanup (SLIC) sites. Beginning July 1, 2005, electronic submittal of a complete copy of all reports for all sites is required in GeoTracker (in PDF format). PERJURY STATEMENT

All work plans, technical reports, or technical documents submitted to ACEH must be accompanied by a cover letter from the responsible party that states, at a minimum, the following: "I declare, under penalty of perjury, that the information and/or recommendations contained in the attached document or report is true and correct to the best of my knowledge." This letter must be signed by an officer or legally authorized representative of your company. Please include a cover letter satisfying these requirements with all future reports and technical documents submitted for this fuel leak case.

PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6735, 6835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

UNDERGROUND STORAGE TANK CLEANUP FUND

Please note that delays in investigation, later reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

AGENCY OVERSIGHT

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.

SUBJECT: Electronic Report Upload (ftp) Instructions

The Alameda County Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of all reports in electronic form to the county's ftp site. Paper copies of reports will no longer be accepted. The electronic copy replaces the paper copy and will be used for all public information requests, regulatory review, and compliance/enforcement activities.

REQUIREMENTS

- Please do not submit reports as attachments to electronic mail.
- Entire report including cover letter must be submitted to the ftp site as a single portable document format (PDF) with no password protection.
- It is preferable that reports be converted to PDF format from their original format, (e.g., Microsoft Word) rather than scanned.
- Signature pages and perjury statements must be included and have either original or electronic signature.
- <u>Do not</u> password protect the document. Once indexed and inserted into the correct electronic case file, the document will be secured in compliance with the County's current security standards and a password. Documents with password protection will not be accepted.
- Each page in the PDF document should be rotated in the direction that will make it easiest to read on a computer monitor.
- Reports must be named and saved using the following naming convention:

Submission Instructions

- 1) Obtain User Name and Password
 - a) Contact the Alameda County Environmental Health Department to obtain a User Name and Password to upload files to the ftp site.

 - b) In the subject line of your request, be sure to include "ftp PASSWORD REQUEST" and in the body of your request, include the Contact Information, Site Addresses, and the Case Numbers (RO# available in Geotracker) you will be posting for.
