Hi Jeff:

ACEH calculates our response date by the date received. Since the original document did not include a perjury statement and was not uploaded to the ftp site, it was not officially accepted by ACEH until January 3, 2013. I referred back to my 8/29/12 Directive Letter in which I requested submittal of the *SCM and Data Gap Work Plan* on 11/2/12, so the document was submitted past the due date and without a prior request for a due date extension. In the future, if there is a schedule to be met, it would be beneficial to meet the deadlines and follow the ftp upload directions to ensure that the documents are submitted electronically and in a timely manner to the County's ftp site.

I'm forwarding the ACEH document acceptance e-mail I was cc'd on and please note that the e-mail cites the 60 day review period:

"Your recently submitted document was successfully uploaded to the Alameda County Environmental Health Toxics Program ftp site. The electronic copy replaces the paper copy and will be used for all public information requests, regulatory review, and compliance/enforcement activities."
