I want to follow up with you regarding the status of work at the subject site. As you know subsequent to a meeting with Alameda County Environmental Health (ACEH) and Salvation Army on February 15, 2013, ACEH requested a soil and groundwater investigation be conducted at the subject property on May 31, 2013 (see attached). The Directive letter required the results of the investigation be presented in a site conceptual model with data gap identification report and uploaded to both the ACEH ftp site and the State Water Resources Control Board's (SWRCB) Geotracker website by August 30, 2013.

Based on a review of the case file to date, the requisite documents have not been uploaded and therefore your site is out of compliance with ACEH's directives.
