

	COMMENTS Subject site is hybrid system with aboveground tank and underground piping. Release identified by Sewer District based on gasoline detected in discharge, later traced to oil water separator and ultimately to a vacant dispenser position. Ongoing remedial actions to date consist of exploratory excavation and recovery of approximately 900 gallons gasoline from piping trench. Additional response/remediation is ongoing. Hazardous Material Incident Report is being prepared for submittal to the OES.
