- Phase I Environmental Assessment Report and Phase II Subsurface Investigation, (Phase I/II Report) dated December 18, 1997, prepared by PES Environmental Inc. (PES) on behalf of Burnham Pacific Properties Inc.;
- Limited Subsurface Assessment Report (Subsurface Report) dated March 13, 2012, prepared by ATC Associates (ATC) on your behalf;
- Site Conceptual Model, dated November 30, 2012, prepared by Cardno ATC on your behalf;
- Data Gap Work Plan, dated November 30, 2012, prepared by Cardno ATC on your behalf;

Thank you for submittal of these documents. Prior to finalizing our comments on the SCM and approving the Data Gap Work Plan, ACEH would like to schedule a teleconference call with you and your consultant to discuss our review of the above listed documents and the proposed scope of work. ACEH concurs that additional investigation activities need to be conducted at the site to define the extent of impacts to soil, groundwater, and soil gas due to the release from the Dryclean 580 facility, and to assess vapor intrusion to indoor air in the drycleaner and adjacent facilities in the 580 Market Place Shopping Center. However, our review identifies additional data gaps that have not been adequately addressed in the SCM or the Data Gap Work Plan. Therefore, ACEH would like to discuss optimal strategies for data collection and efficiency of field mobilizations.
