Dilan -

I may have remembered incorrectly – it may be only Alameda Co. sites where <u>groundwater</u> is involved that get referred to the RWQCB. Please reply to let me know whether the subject site (ECHOJ) will be handled by your office (and by you specifically?).

In our phone conversation Wednesday, you indicated that the criteria that ACEH uses for allowing re-use of soil in an excavation is the RWQCB's "*Characterization and Reuse of Petroleum Hydrocarbon Impacted Soil as Inert Waste*" dated (Oct '06). Per that document, it looks like the stockpiled soil (about 25 cu. yds.) represented by only one of our samples (C3-1) are allowed to be re-used as fill under Category 1 of the evaluation process. I have attached a site plan and sample location map for reference.

Let me know what you need to see in terms of getting this approved. Thanks!
