PUBLIC NOTIFICATION OF POTENTIAL CASE CLOSURE OF FUEL LEAK CASE Agesong

Site Location: 4050 Horton Street, Emeryville, CA 94608 Fuel Leak Case RO0003103 and GeoTracker Global ID T10000004352

Summary – This fact sheet has been prepared to inform community members and other interested parties of potential case closure for a fuel leak case at the former Agesong Bayside Park, a senior residential board and care facility. The facility is located at the northeast corner of Horton and 40th Streets in Emeryville, California. Surrounding land use is commercial. A 500-gallon heating oil underground storage tank (UST) was installed on the property at an unknown date. As currently developed the data for the site does not indicate that the petroleum release presents a risk to human health or the environment.

Background - On June 18, 2008, the 500-gallon heating oil underground storage tank was removed from the property. The tank was observed to be in poor condition, with at least one observable hole. Visible staining and odors were also noted in the soil underlying the tank. Groundwater was not encountered during the excavation.


Total Petroleum Hydrocarbons were not detected in the two soil samples collected beneath the UST at a depth of 6.5 feet below surface grade (bgs). The soil samples were additionally analyzed for benzene, toluene, ethylbenzene, and xylenes (BTEX), methyl tertiary butyl ether (MTBE), and other volatile organic compounds (VOCs). No BTEX, MTBE, or other VOCs


were detected in the two soil samples. The UST excavation was subsequently overexcavated to 8.5 feet for building construction. Additional confirmation sampling was not performed and the building was constructed on the site. It appears that any residual contamination that may be present was removed to a depth of 8.5 feet bgs.

This fuel leak case has been evaluated for closure consistent with the criteria in the State Water Resource Control Board's Low Threat Closure Policy (LTCP). Sites that meet the general and media-specific criteria in the LTCP are considered to not pose a threat to human health, safety, or the environment and are appropriate for closure pursuant to Health and Safety Code section 25296.10. Residual petroleum hydrocarbons that may potentially be present in soil or groundwater are expected to biodegrade over time. It does not appear that the site presents a risk to human health for site users or residents. Therefore, Alameda County Environmental Health (ACEH) is considering potential closure of the fuel leak case.

Next Step - The public is invited to review and comment on the potential closure of the fuel leak case.
