Thank you for sending CST Brands response to Alameda County Department of Environmental Health's (ACDEH) Notice of Responsibility (NOR) updated on August 21, 2015. Based on the information you sent, I have revised the NOR naming Valero Energy as a Responsible Party (RP). Please note that your response indicated that National Convenience Stores Incorporated (NCS) was acquired by Valero Energy Corporation, which maintained NCS as a subsidiary, and also created CST as a subsidiary. Based on that statement, I reviewed Valero Energy's List of Subsidiaries as of February 1, 2007 and note that National Convenience Stores Incorporated was included on the list. However, I also reviewed CST Brand's List of Subsidiaries as of August 27, 2013 and note that National Convenience Stores Incorporated was included as a subsidiary of CST Brand. Based on this data, it appears that CST can still be included as an RP for the site. I've attached Valero Energy and CST Brand's List of Subsidiaries as listed by the Securities and Exchange Commission (SEC). If this has changed since August 2013, please let me know and ACDEH will evaluate removing CST Brands from the revised NOR. Please include documentation supporting your response.
