## Hello Marc:

The work plan was submitted to ACEH on 6/11/2014 and I understand from your consultant Paul Dodson (TEC Environmental) that you urgently wish to start the field work without work plan approval from ACEH. Although ACEH will make every reasonable effort to expeditiously respond to submittals received, this is the end of the fiscal year (6/30/2014) and I won't be able to review the work plan at least until the beginning of July. Should you continue to proceed with the fieldwork, you would be doing so without concurrence from ACEH. If no comments arise from the review of the work plan, then proceeding with the fieldwork would not appear to have any significant repercussions. However, if comments to the work plan are identified which warrant the preparation and submittal of work plan addendum, or if modifications to the fieldwork are found to be necessary, additional mobilizations may be required. Please note that the Underground Storage Tank Cleanup Fund (USTCF) typically reimburses costs for a scope of work that has been approved by a regulatory agency. Since a review of the work plan cannot be completed in the requested time frame and if the scope of work is implemented prior to regulatory approval, the USTCF may not fully reimburse all costs associated with the proposed scope of work.
