Alameda County Environmental Health (ACEH) staff has reviewed the Site Cleanup Program (SCP) case file for the above referenced site including the recently submitted document entitled, "Site Management Plan, Public Storage #CA13186, 6800 Overlake Place, Newark, California," dated December 8, 2014 (SMP). The SMP, which was prepared on your behalf by Antea Group, presents plans to remove, relocate, and manage shallow soils containing slag material during and after construction of a planned storage facility. The slag, which contains elevated concentrations of lead, will be removed from areas where it may be encountered by current or future receptors and relocated beneath building slabs or asphalt pavement. The SMP includes procedures for managing the slag in place beneath the cap following cap construction.

ACEH provided technical comments on a draft SMP dated November 25, 2014. The revisions in the December 8, 2014 SMP appear to adequately address our comments. Therefore, the proposed plans in the SMP dated December 8, 2014 are acceptable for public comment. Public participation is a requirement for the corrective action and case closure process. In order to notify potentially affected members of the public of the proposed corrective action and potential case closure, the attached "*Invitation to Comment – Corrective Action*," was distributed to the addresses shown on the attached mailing list. We request that provide the names and addresses of any persons, corporations, or government agencies you are aware of that may also have an interest in this SCP case. The Invitation to Comment requests that landowners or residents submit any comments or questions to ACEH regarding the proposed corrective action by January 13, 2015. ACEH will consider all comments from the public prior to final approval of the proposed corrective action. Upon completion of the public comment period, ACEH will forward any comments to the responsible parties. If no comments are received, ACEH will provide written confirmation of the completion of the public comment period.

The above referenced site is a Site Cleanup Program (SCP) case that is under the regulatory oversight of Alameda County Environmental Health (ACEH) for investigation and corrective action related to slag material in shallow fill at the site. The slag contains metals at concentrations above background concentrations. Lead was detected in the shallow fill material at concentrations above human health screening levels. The site is currently vacant but redevelopment as a storage facility is planned.

To prevent future exposure, the slag material in shallow fill will be capped or removed from areas where it could be encountered by current or future workers or visitors or where it could be transported off-site by wind or stormwater. The slag will remain or be relocated beneath proposed buildings and pavement. A Site Management Plan dated December 8, 2014 describes the procedures for proper handling of slag-containing materials during site construction. Following removal and capping of the slag material, the SCP case will be closed with site management requirements regarding future land use and maintenance of the cap. Post-construction requirements for maintenance and annual reporting on the effectiveness of the cap are included in the Site Management Plan. A Covenant and Environmental Restriction on Property will be recorded for the site.

This notice is being sent to the current occupants and landowners of adjacent properties and known interested parties for this site. The public is invited to review and comment on the corrective action. Comments received by January 13, 2015 will be considered and responded to prior to a final determination on the corrective action.
