P&D Environmental, Inc. (P&D) has prepared this report documenting the destruction of one soil gas well designated as SG1 at the subject site.

The well was destroyed in accordance with Alameda County Public Works Agency (ACPWA) permit requirements (permit number W2014-1109) on November 19, 2014 by IMX, Inc. (IMX) of Oakland, California by hand augering to a depth of 5.0 feet using a 4-inch outside diameter hand auger. The borehole was then filled with neat cement to approximately one half foot below the ground surface. The well box for the well was removed, and the void space created by removal of the well box was filled with soil and covered with wood chips to match the surrounding landscaping. Mr. Sam Brathwaite was present to observe and document grouting of the well on behalf of ACPWA.




Figure 1 Site Location Map Cathedral Gardens 638 21st Street Oakland, California

A Site Location Map is attached as Figure 1, a Site Vicinity Aerial Photograph showing the soil gas well location is attached as Figure 2, and a Site Plan Detail showing the soil gas well location is attached as Figure 3. A copy of the well destruction permit (Appendix A) is attached with this report.

All waste generated during well destruction activities was removed from the site by IMX for disposal at a local landfill.







Figure 2

### **Specific Work Permit Conditions**

- 1. Permittee shall assume entire responsibility for all activities and uses under this permit and shall indemnify, defend and save the Alameda County Public Works Agency, its officers, agents, and employees free and harmless from any and all expense, cost, liability in connection with or resulting from the exercise of this Permit including, but not limited to, properly damage, personal injury and wrongful death.
- 2. Permittee, permittee's contractors, consultants or agents shall be responsible to assure that all material or waters generated during drilling, boring destruction, and/or other activities associated with this Permit will be safely handled. properly managed, and disposed of according to all applicable federal, state, and local statutes regulating such. In no case shall these materials and/or waters be allowed to enter, or potentially enter, on or off-site storm sewers, dry wells, or waterways or be allowed to move off the property where work is being completed.
- 3. Compliance with the well-sealing specifications shall not exempt the well-sealing contractor from complying with appropriate State reporting-requirements related to well destruction (Sections 13750 through 13755 (Division 7, Chapter 10, Article 3) of the California Water Code). Contractor must complete State DWR Form 188 and mail original to the Alameda County Public Works Agency, Water Resources Section, within 60 days. Include permit number and site map.
- 4. Applicant shall submit the copies of the approved encroachment permit to this office within 60 days.
- 5. Applicant shall contact assigned inspector listed on the top of the permit at least five (5) working days prior to starting,

once the permit has been approved. Confirm the scheduled date(s) at least 24 hours prior to drilling.

- 6. Remove the Christy box or similar structure. Destroy well(s) by overdrilling to total depth & Tremie Grouting with Cement. After the seal has set, backfill the remaining hole with concrete or compacted material to match existing.
- 7. Copy of approved drilling permit must be on site at all times. Failure to present or show proof of the approved permit application on site shall result in a fine of \$500.00.
- 8. Prior to any drilling activities onto any public right-of-ways, it shall be the applicants responsibilities to contact and coordinate a Underground Service Alert (USA), obtain encroachment permit(s), excavation permit(s) or any other permits required for that City or to the County and follow all City or County Ordinances. It shall also be the applicants responsibilities to provide to the Cities or to Alameda County a Traffic Safety Plan for any lane closures or detours planned. No work shall begin until all the permits and requirements have been approved or obtained.
