Regarding the missing bore log for SB4; I did look through my file today and see that no log was produced, however the bore is described in the top paragraph on page 8 of the May 17, 2016 report as follows:

“The boring lithology consisted of an upper 6 inches of garden soil overlying light brown silty clay. Light-green discoloration was noted in bore SB4 between 3-5 feet bgs and a light oil odor was noticeable in the 5 foot sample.”

Maybe this is helpful to you. Will look forward to your directive.
