Responsible Party Identification Background

Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."

2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."

3. "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."

4. "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

Existence of Unauthorized Release

Eleven Assessor's Parcel Numbers (APNs) comprise this case (hereafter referred to as "the Site") and are: 3-23-5-1; 3-23-6-1; 3-23-7-1; 3-23-8-2; 3-23-9-2; 3-23-10-2; 3-23-11-2; 3-25-10; 3-25-11; 3-35-5; and 3-35-6.

In October 1986, a 7,000 gallon diesel underground storage tank (UST) and a 2,000 gallon gasoline UST were removed from the Site. Additional investigations were conducted at the Site in 2005 and 2011 as part of real estate due diligence and planned residential redevelopment. During the 2005 Phase II investigation, conducted at 760 22nd Street concentrations of up to 190 milligrams per kilogram (mg/kg) Total Petroleum Hydrocarbons as Gasoline (TPHg), 250 mg/kg TPH as diesel (TPHd), and 47 mg/kg TPH as waste oil (TPHmo) were documented in soil samples. Concentrations of up to 3,200 micrograms per liter (ug/L) TPHd and 490 ug/L TPHmo were documented in grab groundwater samples. These data indicate that an unauthorized release from the USTs had occurred at the Site.

Responsible Party Identification

Bekins Company (and related entities known as Bekins Company (c/o: Controllers Office); Bekins Van & Storage Co.; and Bekins Moving & Storage Company) purchased or acquired each individual property at various dates: APNs 3-23-5-1 and 3-23-6-1 on September 10, 1970; APN 3-23-7-1 on March 1, 1974; APN 3-23-8-2 on March 5, 1970; APN 3-23-9-2 on March 1, 1969; APN 3-23-10-2 on December 15, 1969; APN 3-23-11-2 on July 22, 1974; APNs 3-25-10 and 3-35-5 on March 1, 1969; APN 3-23-11-0 March 17, 1972; and APN 3-35-6 on December 1, 1967. The Bekins Company (and related entities) is a responsible party because they owned or operated an underground storage tank used for the storage of any hazardous substance (Definition 1); and they were the owners of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred (Definition 3).

GTG Investors (and related entities known as GTG Investors & Wilson Peter H; GTG Investors & Wilson Peter H (c/o: Kentfield Properties); GTG Investors & Oswald Gary P; GTG Investors & Oswald Gary P (c/o: L&W Investors); and GTG Investors (c/o: L&W Investors)) purchased, acquired, or reacquired the properties at various dates on May 7, 1987 (APNs 3-25-10, 3-25-11, 3-23-7-1, 3-23-8-2, 3-23-9-2, and 3-23-11-2); November 24, 1987 (APNs 3-25-11, 3-35-5, 3-23-5-1, 3-23-6-1, 3-23-7-1, 3-23-8-1, 3-23-9-2, 3-23-10-2); and September 26, 1989 (the Site). GTG Investors (and related entities) are a responsible party because they owned the properties where an unauthorized release of a hazardous substance from an underground storage tank has occurred (Definition 3).

West Grand Development Group LLC purchased or acquired the properties (the Site) on June 28, 2007. West Grand Development Group LLC is a responsible party because they owned the properties where an unauthorized release of a hazardous substance from an underground storage tank has occurred (Definition 3).

East West Bank purchased or acquired the properties (the Site) on July 9, 2010. East West Bank is a responsible party because they owned the properties where an unauthorized release of a hazardous substance from an underground storage tank has occurred (Definition 3).

East Bay Asian Local Development purchased or acquired the properties (the Site) on January 3, 2011. East Bay Asian Local Development is a responsible party because they owned the properties where an unauthorized release of a hazardous substance from an underground storage tank has occurred (Definition 3).

West Grand & Brush LLC purchased or acquired the properties (the Site) on June 19, 2014. West Grand & Brush LLC is a responsible party for the site because they are the current owner of the properties where an unauthorized release of a hazardous substance from an underground storage tank has occurred (Definition 3).
