Dear Mr. Skolnick:

Alameda County Department of Environmental Health's (ACDEH) staff is considering the above referenced site for potential case closure. As you are aware a site investigation consisting of the recovery of soil and grab-groundwater (GGW) samples associated with the removal of an underground storage tank has been performed at the subject property to which you are named as the primary or active responsible party.

Electronic Submittal of Information

The Electronic Reporting Regulations (Chapter 30, Division 3 of Title 23 & Division 3 of Title 27, CCR) require electronic submission of any report or data required by a regulatory agency from a cleanup site. Submission dates are set by a Regional Water Board or by a regulatory agency. Once a report/data is successfully uploaded, as required, you have met the reporting requirement (i.e. the compliance measure for electronic submittals to the State Water Resources Control Board's (SWRCBs) GeoTracker database is the actual upload itself). The upload date should be on or prior to the regulatory due date.

ACDEH has made several requests (March 3, 2016, November 4, 2016, June 15, 2017, and December 22, 2017) for electronic submittals pertaining to the UST removal. To date no submittals to GeoTracker have been received. In order to complete our review of the case file, we request that the Electronic Reporting Regulations be met for closure consideration. At a minimum, please submit the EDF and GEO_MAP associated with the document entitled *Underground Storage Tank Closure Report*, dated December 11, 2014 and prepared by Golden Gate Tank Removal (GGTR). Please submit the EDF and GEO_MAP for our review by the date specified below for closure consideration.

Additionally, ACDEH requested the completion and submittal of an Unauthorized Release Form (URF). Our initial request was made on March 14, 2016. Subsequent requests were made on November 4, 2016, June 15, 2017, and December 22, 2017. We have yet to receive the URF. Please complete and submit the URF for our review prior to closure consideration by the date specified below.

Pursuant to Section 25297.15 (a) of the California Health and Safety Code, ACDEH, the local agency, shall not consider cleanup or site closure proposals from the primary or active responsible party, issue a closure letter, or make a determination that no further action is required with respect to a site upon which there was an unauthorized release of hazardous substances from an underground storage tank subject to this chapter unless all current record owners of fee title to the site of the proposed action have been notified of the proposed action by the primary or active responsible party. ACDEH is required to notify the primary or active

responsible party of their requirement to certify in writing to the local agency that the notification requirement in the above-mentioned regulation has been satisfied and to provide the local agency with a complete mailing list of all record fee title owners.

To satisfy this requirement, please complete the enclosed *List of Landowners Form* (LLF), and submit it by the date identified below. Please note that LLF submittal was previously requested on March 3, 2016, November 4, 2016, June 15, 2017, and December 22, 2017.

ACDEH requests notification of the GeoTracker submittals via electronic mail, Attention: Keith Nowell. Please include a listing of the submittals with your notification to our agency. Following receipt of the documents requested above, ACDEH will continue with its closure evaluation.

Instructions for Completing UST Unauthorized Release (Leak) / Contamination Site Report

EMERGENCY: Indicate whether emergency response personnel and equipment were involved at any time. If so, a Hazardous Material Incident Report should be filed with the State Office of Emergency Services (OES). Indicate whether the OES report has been filed as of the date of this report.

<u>LOCAL AGENCY USE ONLY</u>: To avoid duplicate notifications pursuant to Health and safety Code Section 25180.7, a designated government employee should sign and date the form in this block. A signature here <u>does not</u> mean that the leak has been determined to pose a significant threat to human health or safety, only that notification procedures have been followed if required.

REPORTED BY: Enter name, telephone number, and address. Indicate which party you represent and provide company or agency name.

SIGNATURE: Sign the form in the space provided.

<u>RESPONSIBLE PARTY</u>: Enter the name, telephone number, contact person, and address of the party responsible for the leak. The Responsible Party would normally be the tank owner.

SITE LOCATION: Enter information regarding the tank facility. At a minimum, you must provide the facility name and full site address.

IMPLEMENTING AGENCIES: Enter the names of the local agency and Regional Water Quality Control Board having jurisdiction over the site.

<u>SUBSTANCES INVOLVED</u>: Enter the name and quantity lost of the hazardous substance(s) involved. If more than two substances leaked, list the two of most concern for cleanup.

<u>DISCOVERY/ABATEMENT</u>: Provide information regarding the discovery and abatement of the leak.

SOURCE/CAUSE: Indicate the source(s) of leak. Check box(es) indicating the cause(s) of leak.

<u>CASE TYPE</u>: Check one box only. Indicate the Case Type category for this leak. Case Type is based on the most sensitive resource affected. For example, if both soil and ground water have been affected, Case Type will be "Groundwater." Indicate "Drinking Water" only if one or more municipal or domestic water wells have actually been affected. A "Groundwater" designation does not imply that the affected water cannot be, or is not, used for drinking water, but only that water wells have not yet been affected. It is understood that Case Type may change upon further investigation.

<u>CURRENT STATUS</u>: Check one box only. Indicate the category which best describes the Current Status of the case. The response should be relative to the Case Type. For example, if the Case Type is "Groundwater," then Current Status should refer to the status of the ground water investigation or cleanup, as opposed to that of soil. Descriptions of options are as follows:

- > No Action Taken No action has been taken by the Responsible Party beyond initial reporting of the leak.
- ➤ Leak Being Confirmed A leak is suspected at the site, but has not yet been confirmed.
- > Remediation Plan Remediation Plan submitted evaluating long term remediation options. Proposal and implementation schedule for appropriate remediation options also submitted.
- > Preliminary Site Assessment Workplan Submitted Workplan/proposal requested of/submitted by Responsible Party to determine whether ground water has been, or will be, impacted as a result of the release.
- > Preliminary Site Assessment Underway Workplan is being implemented.
- > Case Closed Regional Water Quality Control Board and local agency Local Oversight Program (LOP) agree that no further work is necessary at the site.
- > Pollution Characterization Responsible Party is in the process of fully defining the extent of contamination in soil and ground water and assessing impacts on surface and/or ground water.
- > Post Cleanup Monitoring in Progress Periodic ground water or other monitoring at site, as necessary, to verify and/or evaluate the effectiveness of remedial activities.
- > Cleanup Underway Remediation Plan is being implemented.

IMPORTANT: THE INFORMATION PROVIDED ON THIS FORM IS INTENDED FOR GENERAL STATISTICAL PURPOSES ONLY AND IS NOT TO BE CONSTRUED AS REPRESENTING THE OFFICIAL POSITION OF ANY GOVERNMENTAL AGENCY.

REMEDIAL ACTION: Indicate which actions have been used to clean up or remediate the leak. Descriptions of options are as follows:

- > Cap Site Install horizontal impermeable layer to reduce rainfall infiltration.
- > Containment Barrier Install vertical dike to block horizontal movement of contaminants.
- > Excavate and Dispose Remove contaminated soil and dispose at approved site.
- > Excavate and Treat Remove contaminated soil and treat (includes spreading or land farming).
- > Remove Free Product Remove floating product from water table.
- > Pump and Treat Groundwater Generally employed to remove dissolved contaminants.
- > Enhanced Biodegradation Use of any available technology to promote bacterial decomposition of contaminants.
- Replace Supply Provide alternate water supply to affected parties.
- > Treatment at Hookup Install water treatment devices at each dwelling or other place of use.
- > Vacuum Extract Use pumps or blowers to draw air through soil.
- > Vent Soil Bore holes in soil to allow volatilization of contaminants.
- > No Action Required Incident is minor, requiring no remedial action.
