The referenced site is a Site Cleanup Program (SCP) case due to the presence of soil, groundwater, and soil vapor contamination at the property. Alameda County Environmental Health (ACEH) is the agency providing regulatory oversight for this case. A number of meetings and reviews of case documents have been undertaken since the initial funds request. Previously incurred costs of approximately \$1,000 have accumulated that have not been paid.
