Dear Messrs. Hopkins and Nguyen:

The referenced site is a Site Cleanup Program (SCP) case due to the presence of soil, groundwater, and soil vapor contamination at the property. Alameda County Environmental Health (ACEH) is the agency providing regulatory oversight for this case. A number of meetings and reviews of case documents have been undertaken since the initial funds request. Previously incurred costs of approximately \$2,800 have accumulated that have not been paid. Thus ACEH requires an additional deposit to the oversight account. Consequently please send a check in the amount of \$8,800.00 payable to ACEH. Please send your check to the attention of our Finance Department, copied below.

This deposit may or may not be sufficient to provide all necessary regulatory oversight. ACEH will deduct actual costs incurred based upon the hourly rate specified below. If these funds are insufficient, an additional deposit will be requested. Otherwise, any unused monies will be refunded to you or your designee.

The deposit is authorized in Section 6.92.040L of the Alameda County Ordinance Code. Work on this project is being debited at the Ordinance specified rate, currently \$174.00 per hour. Please write "SCP" (the type of project), the site address, and the account ID AR0346928 on your check.
