Corrected Map of the Jones Tract. (Bk. 4 Pg. 4)

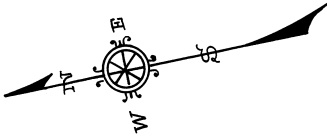

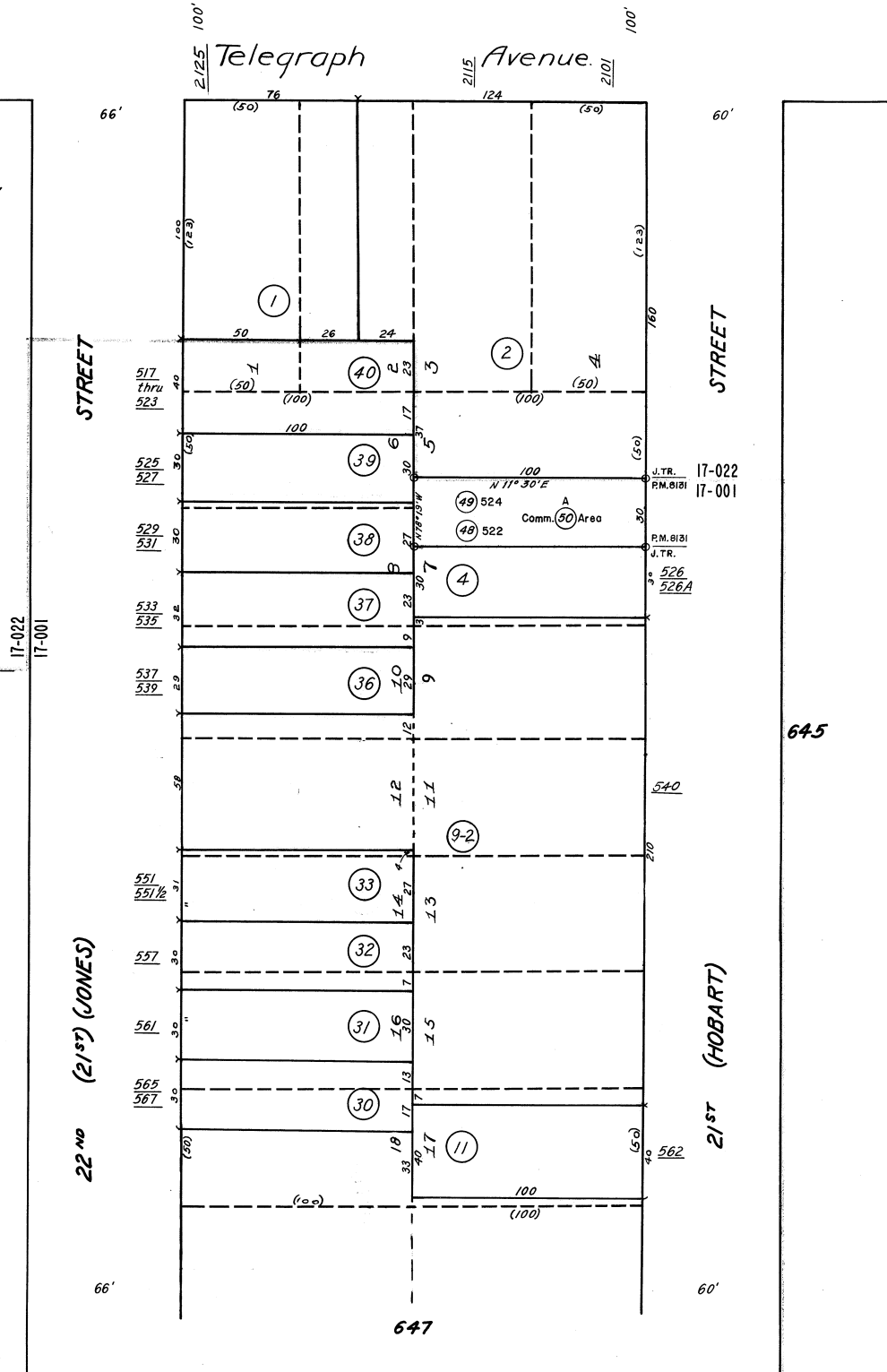
