## Gerald,

Thank you for your voice mail this morning, and the letter dated November 30, 2017, in regards to the foundational element that was encountered at the site. Upon review of it and an internal discussion, the Alameda County Department of Environmental Health (ACDEH) is in agreement with conclusions of the letter that the element did not represent an underground storage tank. Please have it uploaded to Geotracker for the record; I've already placed it on our website. As discussed in the meeting, and as previously requested in the October 10, 2017 directive letter, ACDEH requests a very brief work plan to delineate the extent of contamination offsite in the street. In an attempt to obtain the information in one mobilization, please error conservatively in the number of bores this may require. The work plan should reference previously accepted Standard Operating Procedures (SOPs) to limit the length of the work plan. To accommodate the standard generation time period, I have revised the submittal date to April 27, 2018. Should you have questions, please let me know.
