Alameda County Department of Environmental Health (ACDEH) staff has reviewed the case file including the *Phase II Environmental Site Assessment*, dated October 28, 2015, the *Phase I Environmental Site Assessment*, dated November 16, 2015, the initial *Site Management Plan* (SMP), also dated November 16, 2015, the most recent plan set generated by The Hanover Company, entitled 27th & *Broadway*, *Oakland*, *CA*, dated February 28, 2016, and the final *Site Management Plan*, dated July 22, 2016. Each document was produced, generated, or submitted on your behalf, or on behalf of The Hanover Company, by ENGEO, Incorporated (ENGEO). Thank you for submitting the documents.

The SMP was generated as the result of several meetings and discussions relative to contamination at the site. It was generated to manage the generation of contaminated soil and groundwater that has been documented at the site and which will be encountered during site grading. It will provide guidance and standard procedures to be used during construction due to the generation of potentially contaminated dust in the upper 15 to 20 feet at the site, and in the event of the discovery of unexpected sources of contamination during the grading processes.

Based on the review of the case file ACDEH requests that you address the following technical comments and provide us the documents requested below.

TECHNICAL COMMENTS

- 1. Public Participation Public participation is a requirement for remedial action or the case closure process. In order to notify potentially affected members of the public of remedial actions, ACDEH will distribute the attached Fact Sheet on Environmental Remedial Actions to addresses in the immediate vicinity, and to local agencies with an interest in the proposed redevelopment. The fact sheet requests that landowners, residents, or other interested parties to submit any comments or questions to ACDEH regarding the proposed actions. ACDEH will forward all comments to you from the public prior to approving implementation of the SMP. The public comment period will run between July 25 and August 25, 2016. Once any comments have been responded to, ACDEH will notify you that you may proceed with implementation of the SMP at the site.
- 2. Site Management Plan ACDEH is in general agreement that the SMP is suitable to manage known contamination from historic site uses, and the potential for unexpected contingencies that can be encountered during site redevelopment. Because this document must be available to the public during the public review period, please additionally upload it and other site documents generated during the redevelopment process to Geotracker, as requested in the next technical comment.

Please be aware that ACDEH has not approved implementation of the SMP with this letter, but has determined the document is suitable to manage conditions at the site upon implementation. Once all public comments have been reviewed and responded to, ACDEH will notify you that the SMP can be implemented. A separate letter will be sent to the city of Oakland in regards to the approval status of the SMP.

3. GeoTracker Compliance – A review of the State Water Resources Control Board's (SWRCB) GeoTracker website indicates the site has not been claimed. Because this is a state requirement, ACDEH requests that the site be claimed in GeoTracker by the date identified below. Please note this date is in the near future as site documents must be available to the public during the comment period. A delay in document availability may cause the comment period to be extended.

Pursuant with California Code of Regulations, Title 23, Division 3, Chapter 16, Article 12, Sections 2729 and 2729.1, beginning September 1, 2001, all analytical data, including monitoring well samples, submitted in a report to a regulatory agency as part of the UST or LUST program, must be transmitted electronically to the SWRCB GeoTracker system via the internet. Also, beginning January 1, 2002, all permanent monitoring points utilized to collect groundwater samples (i.e. monitoring wells) and submitted in a report to a regulatory agency, must be surveyed (top of casing) to mean sea level and latitude and longitude to sub-meter accuracy using NAD 83. A California licensed surveyor may be required to perform this work. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs, including VRAP programs. Additionally, pursuant to California Code of Regulations, Title 23, Division 3, Chapter 30, Articles 1 and 2, Sections 3893, 3894, and 3895, beginning July 1, 2005, the successful submittal of electronic information (i.e. report in PDF format) shall replace the requirement for the submittal of a paper copy. Please claim your site and upload all previous and future submittals to GeoTracker and ACEH's ftp server by the date specified below. Electronic reporting is described below on the attachments.

REPORT REQUESTS

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.

ELECTRONIC SUBMITTAL OF REPORTS

ACEH's Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of reports in electronic form. The electronic copy replaces paper copies and is expected to be used for all public information requests, regulatory review, and compliance/enforcement activities. Instructions for submission of electronic documents to the Alameda County Environmental Cleanup Oversight Program FTP site are provided on the attached "Electronic Report Upload Instructions." Submission of reports to the Alameda County FTP site is an addition to existing requirements for electronic submittal of information to the State Water Resources Control Board (SWRCB) GeoTracker website. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs. For several years, responsible parties for cleanup of leaks from underground storage tanks (USTs) have been required to submit groundwater analytical data, surveyed locations of monitoring wells, and other data to the GeoTracker database over the Internet. Beginning July 1, 2005, these same reporting requirements were added to Spills, Leaks, Investigations, and Cleanup (SLIC) sites. Beginning July 1, 2005, electronic submittal of a complete copy of all reports for all sites is required in GeoTracker (in PDF format). PERJURY STATEMENT

All work plans, technical reports, or technical documents submitted to ACEH must be accompanied by a cover letter from the responsible party that states, at a minimum, the following: "I declare, under penalty of perjury, that the information and/or recommendations contained in the attached document or report is true and correct to the best of my knowledge." This letter must be signed by an officer or legally authorized representative of your company. Please include a cover letter satisfying these requirements with all future reports and technical documents submitted for this fuel leak case.

PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6735, 6835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

UNDERGROUND STORAGE TANK CLEANUP FUND

Please note that delays in investigation, later reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

AGENCY OVERSIGHT

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.

Site Remediation Summary

This fact sheet has been prepared to inform community members and other interested stakeholders regarding the status of a proposed soil and groundwater cleanup at the former Sisters of Providence Hospital and the former Chevron service station located at 2630 Broadway, Oakland, California. The prospective purchaser of the site, CRP / THC Oakland Broadway Uptown Venture LLC is proposing to conduct a site wide remedial action excavation to allow site redevelopment as a mixed used retail/residential apartment complex. A remedial action excavation Site Management Plan (SMP) has been generated to address contaminated soils and groundwater that will be encountered during the excavations.

Site Background

The site is located at 2600 to 2650 Broadway in Oakland. The site is approximately 1.1 acres in area and occupies assessor parcel number 9-685-18-6. It is located in a mixed commercial/industrial and residential area of Oakland. It is bounded by Broadway to the west, 27th Street to the north/northeast, and 26th Street to the south.

Known use of the site dates back to at least 1903, when the property was occupied by the Sisters of Providence Hospital. It is understood that the hospital was subsequently demolished between approximately 1910 and 1920. Beginning sometime in 1950, the site was occupied by a used car sales/service lot. Underground storage tanks (USTs) were installed in the western portion of the property in 1962, when the site was first occupied by a petroleum service station. A circular restaurant building was constructed on the eastern portion of the property between 1958 and 1968. In 1998, the petroleum service station was demolished, the USTs were removed, and the site was paved. The paved lot has remained to the present day and the site is currently occupied by a car sales facility and the vacant circular former restaurant building.

Due to the presence of contamination associated with the former petroleum service station, a number of investigations and cleanup actions, including excavation, were conducted between 1982 and 2012. Investigations associated with the service station identified the presence of fill material within a portion of the property with lead and semi-volatile organic compound contamination that appeared to date to the earlier presence of the Sisters of Providence Hospital. Case closure was granted by the Alameda County Department of Environmental Health (ACDEH) under the State Water Board's Low Threat Closure Policy for petroleum hydrocarbon contamination in May 2014. Due to the nature of the earlier contamination, ACDEH required that upon redevelopment further investigation be undertaken to determine the extent of contamination associated with the former hospital.

Proposed Actions

The proposed redevelopment of the site includes excavation across the entire site to a depth of approximately 40 feet. Existing contamination is located in the upper approximately 15 to 20 feet of the surface. The additional investigations conducted at the site indicate that no remaining contamination will be present at the site after the proposed excavation. A limited portion of the former hospital extends off of the site beneath 27th Street and cannot be accessed during the redevelopment.

A SMP has been prepared to manage the presence of contaminated soil and groundwater that will be encountered during excavation, grading, and construction activities; specifically during excavation through the shallower fill material identified to be associated with the former service station and hospital at the site. Excavated contaminated soil will be segregated and transported to appropriately permitted offsite landfills or other disposal facilities.

All work is will be carried out in a manner designed to be protective of the environment and the local community.

What this Means To You

During site excavation activities, increased construction traffic and noise from excavation and loading activities in to trucks to transport the soils offsite site are expected. Dust generation during excavation and loading will be possible, will be actively monitored, and will be actively suppressed to standards set by regulatory agencies, including the Bay Area Air Quality Management District (BAAQMD). Equipment noise is anticipated to be moderate during working hours.

Next Step

CRP/THC Oakland Broadway Uptown Venture LLC, will work with ACDEH to implement the SMP, prepared by their consultant ENGEO, Inc. The public is invited to review and comment on the proposed corrective action. The plan is available on ACDEH's website (http://www.acgov.org/aceh/lop/ust.htm) or the State Water Resources Control Board's GeoTracker website (http://geotracker.waterboards.ca.gov/).


