Dear Mr. Hernon:

Alameda County Department of Environmental Health (ACDEH) staff has been in contact with Shomari Carter of Supervisor Keith Carson's office regarding siting of a temporary car wash at the subject property. As you are aware, the site is the location of a former gasoline station which experienced unauthorized release(s) from the fueling system. The case addressing the fuel release(s), ACDEH case number RO0000251, was closed on August 19, 2015.

As residual petroleum hydrocarbon contamination remains at the site, ACDEH has expressed concerns regarding the infiltration of surface water to the subsurface, that has the potential to adversely affect the localized water table and groundwater flow. Our concern could be addressed by the site having an impervious cover that is in good condition and an appropriate grade to prevent ponding of surface water.

Shomari Carter provided ACDEH site photographs on October 14, 2016. The photographs were taken during, or shortly thereafter, a rain event. Based on the photographs provided to our office, it appears the site conditions are appropriate to receive the car wash. Please be aware that you are responsible for maintaining the integrity of the impervious cover and off-site discharge of surface water at the site. Additionally, the car wash water will need to meet appropriate discharge requirements. I have included some links for reference to the clean water program regarding car washes.
