Alameda County Department of Environmental Health (ACDEH) staff has reviewed the case file for the above referenced site, including the recently submitted report entitled "Revised Work Plan for Additional Site Assessment," dated June 22, 2016. The revised work plan, which was prepared by ATC Group Services LLC (ATC) after our meeting on June 20, 2016, presents plans for soil boring and monitoring well placement to collect soil and groundwater samples and to estimate groundwater flow direction at the site.

The Revised Work Plan addressed our technical comments and may be implemented as proposed.

## Peter and Gabe:

I have completed my review of the Work Plan for Additional Site Assessment, 2820 and 2855 Broadway (Work Plan), prepared by ATC and dated March 16, 2016 in conjunction with the following documents in the case file.

- Limited Phase II Environmental Assessment Report, 2800, 2820, and 2855 Broadway, prepared by ATC and dated December 29, 2015
- Phase I Environmental Site Assessment, prepared by ATC and dated September 4, 2015
- Limited Phase II Subsurface Investigation, prepared by AEI Consultants and dated April 27, 2015

The proposed scope of work presented in the Work Plan includes advancement of 4 borings at 2820 Broadway to further assess the lateral and vertical extent of lead in soil and extent of benzene in groundwater, and three boring at 2855 Broadway to further assess the lateral distribution of carbon tetrachloride in groundwater. However, prior to approving the work plan I would like to schedule a meeting to discuss previously collected data and the proposed scope of work. In order to facilitate discussion at the meeting please bring the following documents to the meeting:

- Boring logs for the Phase II investigation conducted by ATC (not included in the report)
- Revised tables (Table 1, 2, and 3) listing the current Regional Water Quality Control Board Environmental
   Screening Levels (February 2016 Revision 3). The current tables list the December 2015 ESLs which are
   significantly different than the Feb 2016 ESLs. Please be sure to include appropriate ESLs for groundwater and

soil to assist in the evaluation of exposure pathways relative to the proposed site redevelopment (vapor intrusion, direct contact, etc.)

- A table for each property summarizing the rational for previous sample locations and depths and analysis
- Further description including the depth and purpose of the French drain depicted on Figure 2 in the vicinity boring B-21
- A revised Figure 2 showing the estimated direction of groundwater flow
- Site redevelopment plans (if available)

I have availability next week to meet on June 17 at 3 pm or the following week on June 20 at 1 pm. Please let me know if either of these dates or times works for you.
