The referenced site is a Voluntary Remedial Action Program (VRAP) case due to the presence of soil, groundwater, and soil vapor contamination at the property. Alameda County Department of Environmental Health (ACDEH) is the agency providing regulatory oversight for this case. A number of reviews of case documents have been undertaken since the initial funds request, and the initial funds request has been exhausted. Thus ACDEH requires an additional deposit to the oversight account. Consequently, to replenish the account please send a check in the amount of \$6,000.00 payable to ACDEH.
