Peter,

Though contaminant concentrations in EF-5 are elevated relative to the other warehouse samples, it is not out of line with the concentrations observed at other areas of the site. Therefore, ACDEH will approve the use of the material in areas that will be hardscaped, eliminating public exposure to the material.

The warehouse soil is not approved for re-use in the planter areas.

Alternatively, if the anomalous EF-5 sample area is delineated and excluded, we may consider much of the soil beneath the warehouse for general re-use. Let me know if you want us to consider the soil for general re-use.

I will follow up with a formal letter approving the soil re-use outlined above.
