Thank you for providing Alameda County Department of Environmental Health (ACDEH) with the Supplemental Geotechnical Investigation Work Plan (Work Plan) prepared by Stevens, Ferrone & Bailey Engineering Company, Inc. (SFB) and dated March 20, 2018. In the Work Plan, SFB makes reference to a November 17, 2017 Phase I Environmental Site Assessment (Phase I) for the project which was prepared by ENGEO Incorporated (ENGEO). SFB appears to use information contained in the ENGEO Phase I for its evaluation of their geotechnical boring locations with respect to residual contamination at the site.

In order for ACDEH to complete its review of the Work Plan, we request submittal of the ENGEO Phase I to the State Water Board's GeoTracker website. Please notify ACDEH, Attention: Keith Nowell, via electronic mail message at keith.nowell@acgov.org informing us of the document submittal.

As indicated in our correspondence of March 16, 2018, please have your environmental consultant review the scope of work and have them provide a letter documenting that the advancement of the borings will not cause drag-down or cross contamination at the site.
