Existence of Unauthorized Release

On December 8, 2015, one 1,000 gallon underground storage tank (UST) used for light diesel heating fuel was removed from the sidewalk at the southeast side of the site. During the UST removal, 50 tons of impacted soil and 2,800 gallons of impacted groundwater were removed. In addition, dark black oil was found seeping from the sides of the excavation.

On December 8 and 9, 2015, two groundwater samples were collected at the excavation. Total petroleum hydrocarbons as diesel (TPHd) were detected in soil at concentrations up to 16 milligrams per kilogram (mg/kg). TPHd and total petroleum hydrocarbons as gasoline (TPHg) were detected in groundwater at concentrations of up to 50,000 micrograms per liter ($\mu\text{g/L}$) and 280,000 $\mu\text{g/L}$, respectively. Additional site investigation performed on December 23, 2015 showed TPHd and TPH as motor oil (TPH-mo) in groundwater at concentrations up to 2,200 $\mu\text{g/L}$ and 1,700 $\mu\text{g/L}$, respectively. This data indicates that an unauthorized release occurred at the site.

Existence of Unauthorized Release

On December 8, 2015, one 1,000 gallon underground storage tank (UST) used for light diesel heating fuel was removed from the sidewalk at the southeast side of the site. During the UST removal, 50 tons of impacted soil and 2,800 gallons of impacted groundwater were removed. In addition, dark black oil was found seeping from the sides of the excavation.

On December 8 and 9, 2015, two groundwater samples were collected at the excavation. Total petroleum hydrocarbons as diesel (TPHd) were detected in soil at concentrations up to 16 milligrams per kilogram (mg/kg). TPHd and total petroleum hydrocarbons as gasoline (TPHg) were detected in groundwater at concentrations of up to 50,000 micrograms per liter ($\mu\text{g/L}$) and 280,000 $\mu\text{g/L}$, respectively. Additional site investigation performed on December 23, 2015 showed TPHd and TPH as motor oil (TPH-mo) in groundwater at concentrations up to 2,200 $\mu\text{g/L}$ and 1,700 $\mu\text{g/L}$, respectively. This data indicates that an unauthorized release occurred at the site.
