### Gregory,

I wanted to append my earlier email, as I was misremembering the project and in fact ACDEH has communicated with the City of Oakland that we are in conditional agreement with a range of Corrective Actions at the site. That said, additional actions are required of the developers that are in your control; namely the ability to access the site for the investigation that is required to fill data gaps. As correctly stated below, the data gap work plan was just submitted, but has not been reviewed or approved yet. As an additional measure of control ACDEH will require your client's signature on the VRAP agreement that they are in concurrence with the work (but not a party to the agreement). This is a change in our process in order to prevent these problems in the future. Thank you for bringing the matter to our attention.

### Gregory,

Thank you for informing Alameda County Environmental Health (ACDEH) that you and Mr. Hahn were not aware of the project restarting and moving forward. The two best sources of information on the project is the state database Geotracker (see:

http://geotracker.waterboards.ca.gov/profile report.asp?global id=T10000009223) and the ACDEH website. All documents are posted at these two websites as PDFs. The ACDEH website has a bit more information that includes communications at important junctures, so it is best to review both. The Geotracker website has other features which our website does not have. A link to the ACDEH website can be found just beneath my signature below. Use either the site address (914 W. Grand Ave) or the ACDDEH case number of RO0003226 to access the PDF copies on our website.

ACDEH makes no commitments other than to find that a property is developable provided environmental contamination is managed as detailed in various reports. This is then communicated to the City of

Oakland. This project has not reached that point and won't for a while. ACDEH received a data gap work plan last week that is intended to fill gaps in our understanding of contamination that remains at the various parcels. Once conducted, reported, and reviewed, then the site could potentially move into identification of remedial options to allow the development to proceed. This requires additional reporting and that report once reviewed may, or may not, be accepted as an appropriate remedial option. This all takes time, but the site is moving in a relatively expedited fashion. The data gap work plan, once accepted, would require access to Mr. Hahn's property, which your client may or may not grant; thus is in his control.

This is probably a first for us where a property is not aware of ongoing or additional work. It appears we need to rework our agreement process to incorporate property owners. We will be acting on that aspect of incorporate property owners in the agreement next week. Let me know if you have additional questions.
