Dear Mr. Ho and Mr. Yip:

Alameda County Department of Environmental Health (ACDEH) staff has reviewed the case file including the *Data Gap Work Plan*, dated October 11, 2017. The document was generated and submitted on your behalf, by the Cornerstone Earth Group (Cornerstone). As you are aware the work plan review was delayed by contractual issues with the property owner for an extended period of time, and more recently by our case load. Regardless, thank you for submitting the work plan.

The referenced work plan proposed the installation of 32 soil bores to gather additional data at the six contiguous parcels (the site) that have been proposed for residential redevelopment. Soil, grab groundwater, and soil vapor have been proposed for collection. As you are aware, the subject site has historically been used for a variety of purposes through time, including residential housing, various companies including auto and truck repair, a fuel service station. Additionally, based on a review of the general vicinity there are a minimum of three upgradient sites with the potential to contribute contamination to the subject site.

Based on the review of the case file ACDEH requests that you address the following technical comments and send us the documents requested below.

TECHNICAL COMMENTS

- Work Plan Modifications The referenced work plan proposes a series of actions with which ACDEH
 is in general agreement of undertaking; however, ACDEH requests several modifications to the
 approach. Please submit a report by the date specified below.
 - a. Additional Grab Groundwater Sample Location Based on the review of site data, and potential data gaps, ACDEH requests the collection of a grab groundwater sample in the approximate location of the planned soil vapor point at the northeastern corner of 2281 Market Street (APN 5-431-15-5). This sample is intended to additionally assess the potential impact of groundwater beneath the planned building from the former service station across Market Street to the east of the site.
 - b. Depth of Soil Vapor Probes Twenty-one temporary soil vapor probes are proposed to be installed to a depth of eight feet below grade surface (bgs) at the site to further assess soil vapor beneath the site. The redevelopment currently plans two levels on the lower first floor, a five foot bgs level in retail areas, and a three foot bgs level in the majority of the area. However, the work plan proposes a single depth for installation of the temporary probes of eight feet bgs. ACDEH requests that the temporary probes be installed to a depth of five feet below the future planned floor elevation, consistent with DTSC guidance, unless the depth of groundwater is an issue. Thus for the future retail area, the depth of installation should be on the order of 10 feet bgs due to the planned floor at a depth of five feet bgs.

c. Vapor Shroud Tracer Concentrations – Please ensure to document and tabulate the concentration of the tracer gas in each vapor shroud. Consistency of shroud tracer methodology between vapor sample locations has become a problem at a number of sites.

REPORT & DELIVERABLE REQUESTS

SECTION: ACDEH Procedures

Alameda County Department of Environmental Health (ACDEH) Cleanup Oversight Programs, Local Oversight Program (LOP) and Site Cleanup Program (SCP) require submission of all reports in electronic form to the State Water Board's (SWB) GeoTracker website in accordance with California Code of Regulations, Chapter 30, Division3, Title 23 and Division 3, Title 27.

<u>Leaking Underground Fuel Tank (LUFT) Cases</u>

Reports and deliverable requests are pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party (RP) in conjunction with an unauthorized release from a petroleum underground storage tank (UST) system.

Site Cleanup Program (SCP) Cases

For non-petroleum UST cases, reports and deliverables requests are pursuant to California Health and Safety Code Section 101480.

ELECTRONIC SUBMITTAL OF REPORTS

A complete report submittal includes the PDF report and all associated electronic data files, including but not limited to GEO_MAP, GEO_XY, GEO_Z, GEO_BORE, GEO_WELL, and laboratory analytical data in Electronic Deliverable Format[™] (EDF). All work plans, technical reports, or technical documents submitted to ACDEH must be accompanied by a cover letter from the responsible party that states, at a minimum, the following: "I have read and acknowledge the content, recommendations and/or conclusions contained in the attached document or report submitted on my behalf to the State Water Board's GeoTracker website." This letter must be signed by the Responsible Party, or legally authorized representative of the Responsible Party.

PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6731, 6735, and 7835) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately licensed or certified professional and include the professional registration stamp, signature, and statement of professional certification. AGENCY OVERSIGHT

Significant delays in conducting site assessment/cleanup or report submittals may result in referral of the case to the Regional Water Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.
