Hi Rob:

Alameda County Department of Environmental Health (ACDEH) appreciates the huge level of effort to upload the documents to ACDEH's ftp site and to Geotracker, is in the process of reviewing the submitted documents. ACDEH's comments concerning the submitted documents will be sent under separate cover. However, one document that I haven't located so far is the reporting of the May 15, 2017 installation of the soil boring/soil gas probes and the May 17, 2017 soil gas sample collection. I found the soil gas results EDF submittal uploaded to Geotracker and a table summarizing the soil gas results in the June 21, 2017 *Summary of Environmental Activities Report* prepared on Lennar's behalf by GeoSolve, Inc. but request a stand-alone report including text, analytical results, a summary table, and a figure.

The closure process will start after upload, review, and acceptance of the requested documents to ACDEH's ftp site and to GeoTracker. The first step of the closure process will be a 30 day public comment period. If comments are received, they will have to be addressed; if no comments are received, then ACDEH will inform LENNAR in writing that the three wells can be destroyed. Upon submittal and acceptance of the well destruction report including signed profile and signed disposal documentation of the waste (both well decommissioning and remaining site waste), the Case Closure package will be issued within 30 days.
