Dear Ms. Gleason:

On behalf of The Garfinkle Trust, Terraphase Engineering Inc. (Terraphase) prepared this summary of findings resulting from research into the historical use of Alameda County Assessor's Parcel Number (APN) 070-0184-015-00, under the addresses 1200 and 1210 Park Street and 2407 San Jose Avenue in Alameda, California ("the site", Figure 1 – Site Map). A review of property history and chemical use information for 1222 Park Street, which was formerly occupied by Bernardi Cleaners, was also conducted. Our research is summarized below and reported in detail in the attached Tables (Table 1 – Summary of Occupancy and Building Use History - 2407 San Jose Avenue; Table 2 – Summary of Occupancy and Building Use History - 1220 and 1210 Park Street; Table 3 – Summary of Occupancy and Building Use History - 1222 Park Street.) Unfortunately, no facility maps or diagrams for 1200 or 1210 Park Street or 2407 San Jose Avenue were uncovered during this investigation.

We understand that the Alameda County Department of Environmental Health (ACDEH) requested historical use information for the site in their Technical Report Request dated December 5, 2016, and that this report will be submitted to the ACDEH in response to that request.

Background

The site at 1200 Park Street has historically included two additional addresses within parcel 070-0184-015-00; 1210 Park Street (smaller building in the northwestern corner of the parcel) and 2407 San Jose Avenue (larger building along the southeastern boundary of the parcel). The historical locations of these two buildings are shown on Figure 2 – Historical Site Details.

Our document review identified that in 1983, the 1210 Park Street and the 2407 San Jose Avenue addresses were merged into one and were hence forth referred to as 1200 Park Street. However, prior to 1983 there appears to be some use of the 1200 address in the files maintained by local agencies. Our historical research also identified the historical use of 1222 Park Avenue as Bernardi Cleaners, a cleaning plant from 1945 until 2000. The former Bernardi Cleaners property is located approximately 105 feet northeast of the site (see Figure 2). A restaurant currently occupies 1222 Park Street.

Our research focused on historical uses of the site other than as a retail gasoline (service) station and included historical and current uses for automobile repair (1200/1210 Park Street building), and metal fabrication (2407 San Jose Street building). Our research into the historical use of the 2407 San Jose Street building uncovered historical use of that building by Chevron in the 1960s.

Scope of Work Completed

Terraphase completed the following scope of work for this report:

- Interviews with Ben Garfinkle and Jay Garfinkle
- Review of available documents on file with the ACDEH
- Review of available documents on file with the City of Alameda Fire Department
- Review of available documents on file with the City of Alameda Building Department
- Review of historical maps and directories at the City of Alameda Public Library
- Review of environmental records database provided by Environmental Record Search
- Review of historical topographic maps
- Review of historical aerial photographs
- Review of historical city directories
- Review of historical fire insurance maps
- Review of a preliminary title report
- Conducted a limited site reconnaissance visit on November 9, 2016
- Preparation of tables summarizing site histories for 2407 San Jose Avenue (Table 1), 1200 and 1210
 Park Street (Table 2), and 1222 Park Street (Table 3)

Results

2407 San Jose Avenue

- Table 1 presents historical site use information for the address 2407 San Jose Avenue, which
 corresponds to the larger building at the southeastern boundary of the site. As noted above, at various
 points in time, the building has also been known as 1200 Park Street. As shown in detail on Table 1,
 beginning in approximately 1922, this building was used for metals fabrication and then as an auto
 service garage (including use by "Hoagys Chevron Service" in 1965), through present day.
- Based on the documents reviewed, and as summarized in Table 1, chemicals used at the 2407 San Jose
 Avenue address included: lacquer thinner, paint thinner, mineral oil, paint, cleaning solvent, motor oil,
 and degreaser (hot tank) contents.
- No facility maps or diagrams for this facility were uncovered during this investigation.

1200 and 1210 Park Street

- Table 2 presents historical site use information for the 1200 and 1210 Park Street addresses, which include both the smaller building at the northwest corner of the site and the larger building at the southeastern boundary of the site. Initially this address is described as an auto service garage in 1922 and as a Standard Oil service station beginning in 1928. Automotive repair conducted by Big O Tires continues at this location today. The gas station was closed and the all but one of the USTs were removed by 1978. In 1988, a waste oil underground storage tank (UST) was removed by Chevron.
- Based on the documents reviewed, and as summarized in Table 2, chemicals used at the 1200 and 1210 Park Street addresses, excluding the contents of the service station USTs, included: motor oil (lube), waste oil and grease, solvent (in Safety-Kleen solvent sink), brake fluid, waste liquid (gasoline and solvent mixture), and coolant/antifreeze.
- The City of Alameda Fire Department and the City of Alameda Building Department prohibit copying of site plans or building layouts. Thus, no maps for these facilities are included in this report.

1222 Park Avenue

- Table 3 presents historical site use information for 1222 Park Street address (requested by our client), which was formerly occupied by Bernardi Cleaners, a cleaning plant that used dry cleaning solvents.
 Bernardi Valet Service cleaning and dying, cleaning plant, and Bernardi Cleaners operated at this location from 1945 until the 2000s.
- Based on the documents reviewed, chemicals used at the 1222 Park Street address included: liquids with halogenated organic compounds.
