Dear Mr. Deutscher:

Alameda County Department of Environmental Health (ACDEH) staff has reviewed the case file for the above referenced site including the recently submitted document *Workplan for Site Characterization* (Work Plan), dated December 29, 2016. The Work Plan, which was prepared on your behalf by ENGEO, presents plans to assess potential soil and soil gas impacts at the parcels associated with 20785 and 20957 Baker Road, which are identified as Assessor's Parcel Numbers (APNs) 84A-16-5-9 and 84A-16-6-4, respectively. This purpose of this assessment is to further delineate site contamination due to historic practices and to support residential redevelopment at the site.

It is our understanding that you have a contractual agreement to purchase the property identified as APN 84A-16-6-4 (20957 Baker Road) but you are not the current owner yet. As a result, please note that an access agreement is required prior to the initiation of any additional investigation activities at this property.

TECHNICAL COMMENTS

Based on our review, the proposed scope of work in the December 29, 2016 Work Plan is generally acceptable, provided the following comments are incorporated and addressed during the field implementation:

1) Soil Sampling

 Sampling Details for the Deeper Soil Samples - The deeper samples from the proposed 13 soil sampling locations will be held pending the initial analyses of their respective shallow samples.
 If detections of any tested constituents are present in the shallow samples, then, the deeper sample at each of the respective locations must be analyzed for the full suite of constituents initially tested for.

2) Soil Gas Well Installation and Sampling

- Move the Two Soil Gas Wells to Within the UST Footprint and Describe the Backfill Material in the Tank Cavity - Two soil gas wells were indicated to be installed within the former UST footprint. However, these locations are observed to be north of the UST footprint. Please move these locations to within the tank cavity and describe what the cavity has been backfilled with when it was excavated and backfilled.
- Addition of Fixed Gasses to the Constituent List Please add oxygen, carbon dioxide, methane and helium by Modified ASTM Method D-1946 to monitor for biodegradation and natural attenuation indicator; and helium which is used to monitor potential leaks in the sampling train.

3) Figures 3 and 8

Note that on each of Figures 3 and 8, there are two locations labeled as SB-5. Please correct this error.

REPORT REQUESTS

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.

ELECTRONIC SUBMITTAL OF REPORTS

Alameda County Department of Environmental Health's (ACDEH) Environmental Cleanup Oversight Programs, Local Oversight Program (LOP) and Site Cleanup Program (SCP) require submission of reports in electronic form. The electronic copy replaces paper copies and is expected to be used for all public information requests, regulatory review, and compliance/enforcement activities. Instructions for submission of electronic documents to the Alameda County Environmental Cleanup Oversight Program File Transfer Protocol (FTP) site are provided on the attached "Electronic Report Upload Instructions." Submission of reports to the Alameda County FTP site is an addition to existing requirements for electronic submittal of information to the State Water Resources Control Board (SWRCB) GeoTracker website. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs. For several years, responsible parties for cleanup of leaks from underground storage tanks (USTs) have been required to submit groundwater analytical data, surveyed locations of monitoring wells, and other data to the GeoTracker database over the Internet. Beginning July 1, 2005, these same reporting requirements were added to SCP sites. Beginning July 1, 2005, electronic submittal of a complete copy of all reports for all sites is required in GeoTracker (in PDF format). Please visit the SWRCB website (http://www.waterboards.ca.gov/water_issues/programs/ust/electronic_submittal/) for more information on these requirements.

ACKNOWLEDGEMENT STATEMENT

All work plans, technical reports, or technical documents submitted to ACDEH must be accompanied by a cover letter from the responsible party that states, at a minimum, the following: "I have read and acknowledge the content, recommendations and/or conclusions contained in the attached document or report submitted on my behalf to ACDEH's FTP server and the SWRCB's GeoTracker website." This letter must be signed by an officer or legally authorized representative of your company. Please include a cover letter satisfying these requirements with all future reports and technical documents submitted for this fuel leak case.

PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6731, 6735, and 7835) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately licensed or certified professional. For your submittal to be considered a valid technical report, you are to present site-specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this case meet this requirement. UNDERGROUND STORAGE TANK CLEANUP FUND

AGENCY OVERSIGHT

Paper copies of reports will no longer be accepted. The electronic copy replaces the paper copy and will be used for all public information requests, regulatory review, and compliance/enforcement activities.

REQUIREMENTS

- Please do not submit reports as attachments to electronic mail.
- Entire report including cover letter must be submitted to the ftp site as a single portable document format (PDF) with no password protection.
- It is preferable that reports be converted to PDF format from their original format, (e.g., Microsoft Word) rather than scanned.
- Signature pages and perjury statements must be included and have either original or electronic signature.
- <u>Do not</u> password protect the document. Once indexed and inserted into the correct electronic case file, the
 document will be secured in compliance with the County's current security standards and a password. <u>Documents</u>
 with password protection will not be accepted.
- Each page in the PDF document should be rotated in the direction that will make it easiest to read on a computer monitor.
- Reports must be named and saved using the following naming convention:

Submission Instructions

- 1) Obtain User Name and Password
 - a) Contact the Alameda County Environmental Health Department to obtain a User Name and Password to upload files to the ftp site.
