Dear Mr. Mashhoon:

Thank you for meeting with Alameda County Department of Environmental Health (ACDEH) staff in our office on March 6, 2018, to discuss the subject site. The meeting was requested by all stake holders to review site data and determine a path forward for the redevelopment of the site.

Data presented in the meeting documented the continuation of pilot testing past the ACDEH approved 30 day period, and the lack of subsequent rebound testing as discussed in the August 23, 2017 directive letter.

Based on discussions at the meeting, we request that you address the following technical comments and send us the reports described below.

# **TECHNICAL COMMENTS**

- 1. Initiate Rebound Testing In accordance with the discussion in the meeting, ACDEH requests that Dual Phase Extraction (DPE) be terminated immediately. ACDEH will provide directives for rebound monitoring upon submittal and review of a report documenting the recent soil, groundwater and soil vapor sampling and pilot test conducted at the site.
- 2. GeoTracker Compliance A review of the State Water Resources Control Board's (State Water Board) GeoTracker database indicates the site has not been claimed and no reports and data analytical data have been uploaded to the case file. Because this is a state requirement, ACDEH requests that the site be claimed in GeoTracker by the date identified below. Therefore, please claim your site and upload all requisite documents and data to GeoTracker by the date specified below. Please reference Attachment A for information on electronic reporting requirements and Responsible Party (ies) Legal Requirements/Obligations.

Pursuant to California Code of Regulations, Title 23, Division 3, Chapter 30 electronic copies of all site related documents must be transmitted electronically (in PDF format) to the State Water Board GeoTracker data base via the internet. Additionally all water level measurements and analytical data including soil, soil vapor, groundwater, surface water, indoor air, and ambient air samples, must be uploaded in electronic deliverable format (EDF). Also, all permanent monitoring points utilized to collect soil vapor and groundwater samples (i.e. monitoring wells) must be surveyed (top of casing) by a California licensed surveyor to mean sea level and latitude and longitude to sub-meter accuracy using NAD 83. California Code of Regulations, Title 23, Division 3, Chapter 30, Articles 1 and 2, Sections 389 and 3894. #### REPORT & DELIVERABLE REQUESTS

Alameda County Department of Environmental Health (ACDEH) Cleanup Oversight Programs, Local Oversight Program (LOP) and Site Cleanup Program (SCP) require submission of all reports in electronic form to the State Water Board's (SWB) GeoTracker website in accordance with California Code of Regulations, Chapter 30, Division3, Title 23 and Division 3, Title 27.

#### Leaking Underground Fuel Tank (LUFT) Cases

Reports and deliverable requests are pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party (RP) in conjunction with an unauthorized release from a petroleum underground storage tank (UST) system.

#### Site Cleanup Program (SCP) Cases

For non-petroleum UST cases, reports and deliverables requests are pursuant to California Health and Safety Code Section 101480.

### ELECTRONIC SUBMITTAL OF REPORTS

A complete report submittal includes the PDF report and all associated electronic data files, including but not limited to GEO\_MAP, GEO\_XY, GEO\_Z, GEO\_BORE, GEO\_WELL, and laboratory analytical data in Electronic Deliverable Format<sup>™</sup> (EDF). - Do not upload draft reports to GeoTracker
- Rotate each page in the PDF document in the direction that will make it easiest to read on a computer monitor.

California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.
