### UNDERGROUND STORAGE TANK CLEANUP FUND (FUND) NOTICE OF ELIGIBILITY DETERMINATION: CLAIM NUMBER 020400 FOR SITE ADDRESS 170 WOODLAND WAY, PIEDMONT

The initial review of your claim is complete. It has been accepted for placement on the Priority List in Priority Class "A", with a deductible of \$0.00. You may view the claims on the annual priority List on the Fund's website at:

All active Priority Class A, B, and C claims must have an annual site budget prior to receiving an LOC. The budget is based on the site-specific needs of the claim, the Fund's projected annual revenue, local regulatory priorities, and direction from the State Water Resources Control Board.

Cleanup Fund technical staff placed each active Priority Class A, B, and C claim into one of five budget categories:

- SWI = Soil and Groundwater Investigation;
- RS/IRA = Remedy Selection and/or Interim Remedial Action;
- CAP/REM = Active Remediation based on an approved CAP;
- VM = Verification Monitoring following remediation and/or long-term monitoring;
- SC = Site Closeout (Formerly 'No Further Action').

The primary objective of the budget is to help the Cleanup Fund manage both short-term and overall claim-specific cash flow. The amount of funding available for each claim is limited according to the overall funding available during the fiscal year, priority class of the claim, and phase of cleanup.

Cleanup Fund technical staff have assigned the following budget category and allocation of funds for your claim:


This budget is only for future corrective action costs incurred after June 30, 2017. The Fund recognizes that this budget may not be adequate to cover all yearly activities that regulators and claimants would like to accomplish. If additional funding is available, the Fund may increase site budgets beyond the initial funding limit, allowing additional work to be performed that year.

Please continue to comply with existing regulatory directives. The Cleanup Fund recommends that you discuss with your regulator strategies to continue corrective action work on a smaller scale, or in a phased approach if necessary.
