Good Afternoon Mark and Eric,

Just following up with the voicemail I left Eric this afternoon, I have returned from maternity leave as of this afternoon and am responding to your status request for this site. ACDEH is currently in the process of creating the NORs for this site and plan issue the NORs and concurrently provide comments for the draft work plan within the next two weeks, however, this will require the responsible party (RP) to be in compliance with the State Water Resources Control Board's Geotracker website. As discussed during our meeting, the site must be in compliance with the GeoTracker website in order for ACDEH to complete our review. Review of GeoTracker indicates this site has not yet been claimed by the RP. Because this is a state requirement, the RP must claim this site on GeoTracker. Additionally discussed during our meeting was the current property owner for this site, current County Assessor's records indicate the current property owner as Danny Liles Trust, however, you have indicated you are working on behalf of Anthony DiGenova Trust. A copy of the County Assessor information is attached for your reference. ACDEH notes the current property owner must claim this site as the RP.

Following the claim of the Site, please upload any and all documents pertaining to the current and historic investigations, including phase I and Phase II Environmental Site Assessments, Tank Removal/Upgrade reports, and Site Maps depicting the current and historic locations of tanks, conveyance piping, hydraulic lifts and other environmentally relevant features (eg: boring locations, building foundations, excavation extents). Please note that the case will need to be claimed in GeoTracker prior to uploading files to the SWRCB website.

Additionally, GeoTracker requires electronic submittal of information (ESI). Hence, once the site is claimed, please upload the laboratory analysis report(s) in electronic deliverable format (EDF), reports (GEO\_REPORTs) and figures (GEO\_MAPs) to GeoTracker. **More** information regarding the SWRCB's GeoTracker website may be obtained online at:
