# **Responsible Party Identification Background**

Alameda County Department of Environmental Health (ACDEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party four ways. An RP can be:

- 1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
- 2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
- 3. "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."

### **Existence of Unauthorized Release**

Two 1000 gallon underground storage tank (UST) containing diesel and gasoline was located beneath the sidewalk al the frontage of the Glen Avenue property. The tank measured approximately 12 feet in length and 45 inches in diameter and was constructed of single wall bare steel with welded seams. The age of the tank is unknown. The owner had no prior knowledge of the tank nor is there any indication of previous site investigation activities. The USTs had holes measuring approximately one quarter inch to approximately 3 inches in diameter in both of the USTs. There were visible holes in the tank. Soil samples from UST pit soil samples analyzed for Total Petroleum Hydrocarbons (TPH) and Volatile Organic Carbons (VOC) showed concentrations which indicate an unauthorized release has occurred at the subject site.
