**Amendment to Access Agreement**

Dear Mr. Yi:

Thank you for your continued cooperation in providing Thrifty with access to your property located at 6101 Telegraph Avenue, Oakland, CA 94609, for conducting our semi-annual groundwater sampling activities related to our Thrifty Oil Co. (Thrifty) Gasoline Service Station No. 063, located at 6135 Telegraph Avenue in Oakland, California (Site). The Thrifty site is located adjacent and to the north of your property and is currently operated by ARCO (Exhibit A).

In a letter dated August 26, 2010, the Alameda County Health Care Services (ACHCS) (Attachment A) required that Thrifty conduct additional site assessment activities relating to our Site that include the installation and sampling of two soil borings on your property located at 6101 Telegraph Avenue, Oakland, CA 94609. The site assessment activities to be conducted on your property include the installation and sampling of two (2) soil borings. One soil boring (SV-4) will be installed to a total depth of 3-feet below ground surface (bgs) and a vapor sample will be collected from this boring. The second soil boring (SB-2/SV-2) will be installed to a depth of approximately 30-feet bgs with a vapor sample collected at approximately 3-feet bgs and soil samples collected at 5-feet intervals to the terminal depth of the boring. A plot plan showing the location of the soil borings is attached as **Exhibit A**.

The installation of the two soil borings should be completed in less than one (1) day and can be performed at a convenient time and in a manner to minimize disruption to business operations. Once the soil borings have been completed and the appropriate samples collected (either vapor or vapor and soil), the borings will backfilled with a bentonite grout mix and sealed to match existing surface conditions.

A Thrifty representative would be glad to meet you at your property and explain the scope of the proposed work.



On February 1, 2007 you executed an access agreement granting Thrifty permission to install two groundwater monitoring wells and to conduct sampling on an ongoing basis (**Attachment B**). Since Thrifty already has your permission to access your property on an ongoing regular basis and the proposed assessment activities are similar but less intrusive than the already completed well installations, please consider this letter an amendment to the existing access agreement that you executed on February 1, 2007 and to include the installation and sampling of the abovementioned soil borings SV-4 and SB-2/SV-2.

If you agree with this proposal, please sign and date this letter in the space provided below and mail / fax it back to us, confirming your concurrence. Your cooperation in this matter is greatly appreciated. 

Thank you for the recently submitted document entitled, "Continuous 5-Day Mobile High Vacuum Dual Phase Extraction Report and Workplan to conduct a Continuous 30-Day Mobile High Vacuum Dual-Phase Extraction Event," dated June 9, 2010 (electronically received on June 17, 2010) and the "Additional Site Assessment Workplan," dated February 18, 2009 (electronically received February 23, 2009), which were prepared by Thrifty Oil Company (Thrifty) for the subject site. Alameda County Environmental Health (ACEH) staff has reviewed the case file including the above-mentioned work plans for the above-referenced site.

According to Thrifty, "the HVDPE event was effective in reducing dissolved hydrocarbon concentrations in several monitoring wells and remediating the residual vapor phase hydrocarbon plume at the site." As a result, Thrifty proposes to conduct a continuous 30-day HVDPE event to remediate the residual hydrocarbons in soil and groundwater at the site.

Thrifty also proposes to install an off-site down-gradient monitoring well (MW-9), four soil borings, and four soil vapor sampling probes.

ACEH generally concurs with the proposed HVDPE scope of work and the scope of work may be implemented. However, ACEH is concerned that the proposed monitoring well and boring locations will not adequately characterize the site and assess potential off-site impacts. ACEH requests that you address the following technical comments and send us a work plan addendum as described below.

#### **TECHNICAL COMMENTS**

1. Soil and Groundwater Characterization - Free product was detected at this site when monitoring wells were first installed in 1986. A groundwater extraction system began operation in April 1991. It is reported that 17.95 feet of free product was detected in monitoring well MW-2 in October 1993. Although free product has not been recently

detected, the extent of the soil and groundwater contamination cross-gradient and down-gradient of the site remains uncharacterized and potential impact to adjacent residential properties has not been assessed. In the above-mentioned work plan, Thrifty states that "it is unlikely residents will grant access to their properties in order to advance soil borings, soil vapor probes or groundwater monitoring wells." Since residential properties are directly adjacent and down-gradient of the subject site, off-site assessment is necessary and attempts must be made to gain off-site access. Should site access not be granted, ACEH can at that point intervene and assist in obtaining off-site site access.

Based on groundwater flow direction, additional groundwater sampling and soil vapor points appear necessary between the subject site and proposed groundwater monitoring well MW-9 to adequately characterize the potential off-site impacts. Please propose a scope of work to address the above-mentioned concerns and submit a work plan addendum due by the date specified below.

Submission of reports to the Alameda County FTP site is an addition to existing requirements for electronic submittal of information to the State Water Resources Control Board (SWRCB) GeoTracker website. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs. For several years, responsible parties for cleanup of leaks from underground storage tanks (USTs) have been required to submit groundwater analytical data, surveyed locations of monitoring wells, and other data to the GeoTracker database over the Internet. Beginning July 1, 2005, these same reporting requirements were added to Spills, Leaks, Investigations, and Cleanup (SLIC) sites. Beginning July 1, 2005, electronic submittal of a complete copy of all reports for all sites is required in GeoTracker (in PDF format). The California Business and Professions Code (Sections 6735, 6835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

#### **UNDERGROUND STORAGE TANK CLEANUP FUND**

Please note that delays in investigation, later reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

#### **AGENCY OVERSIGHT**

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.

## ATTACHMENT B

#### ACCESS AGREEMENT

This Access Agreement ("Agreement") is entered into as of \_\_\_\_\_\_\_, 2007, by and between Thrifty Oil Co., a California corporation ("Thrifty"), and Kwon H. Yi & Yong C. Yi ("Owner"), with reference to the following facts:

#### RECITALS

- A. The Alameda County Environmental Health Services ("ACEH") has directed Thrifty to assess if there is any petroleum hydrocarbons present at the property located at 6101 Telegraph Avenue, Oakland, CA 94609 ("Property") which is owned by Owner and which is directly adjacent to a parcel real property owned by Thrifty and having the address of 6125 Telegraph Avenue, Oakland, CA 94609.
- B. In order to comply with the request of the ACEH, Thrifty will need to periodically enter the Property for the purposes of conducting soil and groundwater assessment activities, which will include the drilling, installation, measurements and sampling of one groundwater monitoring well (hereinafter "site assessment activities");

NOW, THEREFORE, in consideration of the mutual covenants, conditions and agreements contained in this Agreement, and for other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, parties hereto agree as follows:

- 1. Permission to Enter. The Owner hereby grants permission to Thrifty to enter the Property for purposes of conducting site assessment activities on the Property. Said site assessment activities include the installation of two groundwater monitoring wells (MW-7 and MW-8) on the Property (in a form substantially similar to the well described in Exhibit "B" attached hereto and incorporated herein), the location of which is more clearly identified in Exhibit "A" attached hereto and incorporated herein. The groundwater from the monitoring well will be periodically sampled by Thrifty personnel, usually once every three months, or as may be required by ACEH. Thrifty will give Owner three days prior notice by fax of any activities which require access onto the Property. Legal abandonment and backfilling of the monitoring well installed on the Property will be Thrifty's sole responsibility and cost when so directed by ACEH or any other environmental agency which acquires jurisdiction of the subject investigation and cleanup. Upon abandoning, removing and backfilling the monitoring well, Thrifty, at its sole expense, will plug the well hole to ground level elevation, and will leave the Property in "broom clean" condition.
- 2. Indemnification. During the duration of the site assessment activities, Thrifty agrees to indemnify, defend and hold harmless the Owner and all of its employees and each of its successors from and against any and all claims, demands, liabilities, losses, causes of action or expenses (including reasonable attorneys' fees) caused by or arising out of the site assessment activities of Thrifty, its employees, contractors or agents, while on the Property, except that no indemnity shall be provided for claims, demands, liabilities, losses, causes of

action, or expenses to the extent caused by or arising out of acts or omissions of the Owner, its employees, agents or invitees.

- 3. Duty to Cooperate. Each of the parties hereto agrees to cooperate with the other in consummating the transaction contemplated hereunder, and agrees without further consideration to execute such further documents and take such further action as may be reasonably necessary or appropriate to effectively consummate the transactions contemplated hereunder.
- 4. Successors and Assigns. This Agreement shall be binding upon and shall inure to the benefit of the successors and assigns of the parties to the Agreement.
- 5. Entire Agreement. This Agreement sets forth the entire agreement between the parties hereto, and, in the event of any conflict between this Agreement and any prior agreement, fully supersedes any and all prior agreements or understanding between the parties hereto pertaining to the subject matter hereof.
- 6. Counterparts. This Agreement may be executed in several counterparts, and all such executed counterparts shall constitute the same Agreement. It shall be necessary to account for only one such counterpart in providing this Agreement. This agreement shall only be binding after a copy of this agreement executed by the Owner has been returned to Thrifty.
- 7. Governing Law. This agreement shall be construed in accordance with and all disputes hereunder shall be governed by the laws of the State of California.
- 8. Notices. Any correspondence conducted under this Agreement shall be in writing and sent to the following addresses of the respective parties by (i) personal delivery, (ii) U.S. Certified Mail return receipt requested, or (iii) by fax:




