#### Responsible Party Identification Background

Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

- 1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
- 2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
- "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."
- "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

ACEH has named the responsible parties for this site as detailed below.

### Responsible Party Identification

#### Existence of Unauthorized Release

On June 15, 1988, one 10,000-gallon underground storage tank was removed from the site. Concentrations up to 680 milligrams per kilogram (mg/kg) Total Petroleum Hydrocarbons (TPH) as gasoline and 11 mg/kg benzene were detected in soil. These data indicate than an unauthorized release had occurred.

## Responsible Party Identification

Leo and Kay Macias and Harold and Faye Schroeder purchased the property in November 1983 and are a responsible party because they owned the property where an unauthorized release has occurred (Definition 3), and had control over an UST at the time of or following an unauthorized release of a hazardous substance (Definition 4).

Robert and Rusty Moody purchased the property in July 1988 and are a responsible party because they owned the property where an unauthorized release has occurred (Definition 3).
