I truly thank you for bearing with us while we have tried since November to set up this conference call regarding ARCO Station 2112 at 1260 Park Street, Alameda, CA (ACEH Case RO44). As you and I have discussed in the recent past one-on-one, Broadbent and BP understand that a negative finding for the question of whether vapor intrusion is a viable pathway for human receptor exposure inside the station building is the last item that ACEH requires prior to processing a case closure certification for the Site.
