Thank you for your cooperation with meeting scheduling to discuss the subject fuel leak case.

To put your fears at rest, no- you are not in jeopardy of business closure. However, the property is contaminated by past release(s) from the station's fueling system. As the result of the releases, the site is an open case with the Alameda County Department of Environmental Health (ACDEH) Local Oversight Program (LOP). ACDEH is unaware of any work which may have occurred at the site since 1996, and has made repeated attempts to move the case toward closure.

The October 6, 2016 meeting is to get all the responsible parties together to develop a path toward closure. As the business owner, you are welcome to join us for the meeting and participate in the discussion. Depending on how the case moves forward, there is a potential for future work to briefly affect station operations.
