Responsible Party Identification Background

Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

- 1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
- 2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
- 3. "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."
- 4. "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

Existence of Unauthorized Release

In April 1985, one of the existing underground storage tanks (USTs) failed a leak test. On June 5, 1985, following installation of three on-site groundwater monitoring wells, free phase product was reported in one well. A waste oil UST was removed on August 19, 1996. Maximum total petroleum hydrocarbon (TPH) concentrations of 57 milligrams per kilogram (mg/Kg) TPH as gasoline (TPH-g) and 800 mg/Kg mg/Kg TPH as diesel (TPH-d) and 210 mg/Kg lead were detected in a soil sample recovered from beneath the tank following its removal. A grab-groundwater (GGW) sample collected from the over-excavated tank pit contained a concentration of 65 micrograms per liter (ug/L) TPH-g and 3,700 ug/L TPH-d. In August 1997, three USTs (one 4,000-gallon gasoline, one 8,000-gallon diesel, and one 9,000-gallon diesel), dispensers, and piping were excavated and removed from the site. Maximum concentrations of TPH-g and TPH-d were reported at 2,500 mg/Kg and 20,000 mg/Kg, respectively. These concentrations indicate an unauthorized release has occurred from the underground storage tank system at this site.

Responsible Party Identification

Chevron Products Company operated a service station on the property into 1983 and maintained a lease for the property into 1985. Chevron Products Company meets the definition of a responsible party for the site because it owned or operated underground storage tanks used for the storage of any hazardous substance (Definition 1) and had control over underground storage tanks at the time of or following an unauthorized release of a hazardous substance (Definition 4).

Hung T. Tran and Hung H. Nguyen et al acquired the property in October 1989. Hung T. Tran and Hung H. Nguyen et al meets the definition of a responsible party for the site because it owned the property where an unauthorized release occurred (Definition 3), and had control over underground storage tanks at the time of or following an unauthorized release of a hazardous substance (Definition 4).

Hung T. Tran and Honghoa T. Nguyen et al acquired the property in May 1989. Hung T. Tran and Honghoa T. Nguyen et al meets the definition of a responsible party for the site because it owned the property where an unauthorized release occurred (Definition 3), and had control over underground storage tanks at the time of or following an unauthorized release of a hazardous substance (Definition 4).

Hung T. Tran and Honghoa T. Nguyen Trust and Trung V. Tran acquired the property in July 2007. Hung T. Tran and Honghoa T. Nguyen Trust and Trung V. Tran meet the definition of responsible parties for the site because they own the property where an unauthorized release occurred (Definition 3).
