## Dear Mr. Plunkett:

I am writing on behalf of 1001 42<sup>nd</sup> Street, LLC ("1001") to request an extension of time to respond to the directives in your letter of July 13, 2009.

As you know, the July 13<sup>th</sup> letter was in response to the following reports previously submitted by 1001 to the ACEHD:

- Screening Level Risk Evaluation, June 5, 2007
- Corrective Action Plan ("CAP"), June 29, 2007
- Work Plan for CAP Implementation, January 31, 2008; and
- Site Conceptual Model ("SCM"), dated November 25, 2008.

As you also know, the ACEHS's July 13, 2009 letter directed that Edward Kozel, ICI Paints, and 1001 submit the following technical reports to the ACEHS by August 30, 2009: (a) Work Plan, (b) Preferential Pathway Study, and (c) Revised SCM. We are hereby requesting a thirty (30) day extension such that these reports would be due by September 30, 2009.

We are requesting this extension so that our consulting firm for this project, AMEC Geomatrix, Inc. ("AMEC"), has adequate time to prepare these reports. As you know, several consultants have been involved in this project in the past, however we have requested that AMEC expand its scope to include response to ACEHS's July 13<sup>th</sup> letter with respect to the SCM and questions that ACEH has raised regarding the proposed CAP. AMEC prepared the Screening Level Risk Evaluation, so AMEC has some background on the project – but AMEC needs additional time to review the CAP and SCM, which were prepared by other consultants.

We have been informed by Schutze Associates that Schutze uploaded certain reports to Geotracker by July 30, 2009, but that the reports do not yet appear on the Geotracker site.
