## To Responsible Parties:

Alameda County Environmental Health (ACEH) staff has reviewed the case file for the above referenced site. Previous site investigation activities have identified two environmental concerns for the site:

- Fuel leaks from two former underground storage tanks (USTs) located in the southern portion of the site
- Imported fill material that contains a tar-like substance.

Based on the nature and extent of the residual contamination, ACEH has determined that regulatory oversight for this site is more appropriate under our Spills, Leaks, Investigations, and Cleanups (SLIC) Program than our Local Oversight Program (LOP) since our LOP is limited to oversight of fuel leaks from underground storage tank systems. Therefore, effective as of the date of this correspondence, the site has been transferred to our SLIC Program.

Unlike the LOP in which funds for regulatory oversight are provided by the State of California, funds for regulatory oversight on the SLIC Program are provided directly by the Responsible Parties. Therefore, we requesting the submittal of a check made payable to Alameda County Environmental Health in the amount of \$6,000.00 as a deposit for regulatory oversight. Please send your check to the attention of our Finance Department. This deposit may or may not be sufficient to provide all necessary regulatory oversight. Funds received by ACEH for SLIC cases such as yours, are held in a deposit/refund account. The deposit/refund account is charged on an hourly basis as case work is performed. If these funds are insufficient, an additional deposit will be requested. Otherwise, any unused monies will be refunded to you or your designee.
