Responsible Party Identification Background

Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

- 1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
- 2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
- 3. "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."
- 4. "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

ACEH has named the responsible parties for this site as detailed below.

Responsible Party Identification

Existence of Unauthorized Release

From at least 1953 to 19769, the site was utilized as an automotive repair facility and gas and oil station. On December 10, 1999, four soil borings were advanced at the site in areas of potential impacts from former operations including the suspected locations of a former underground storage tank (UST). Total recoverable petroleum hydrocarbons and tetrachloroethene (PCE) were detected in soil at concentrations up to 68 and 0.024 milligrams per kilogram, respectively. Total petroleum hydrocarbons as gasoline and PCE were detected in groundwater at concentrations up to 270 and 42 micrograms per liter, respectively. Based on these data, an unauthorized release has occurred at the site.

Responsible Party Identification

Jack and Marilyn Sumski owned the property from 1991 up to 2001. In a Notice of Responsibility dated July 26, 2000, Mr. Sumski was named as a responsible party for the site because Mr. and Ms. Sumski were the property owners where an unauthorized release from a UST occurred (Definition 3).

Jose and Nelly Castellanos purchased the property in 2001. Mr. and Ms. Castellano are responsible parties for the site because they currently own the property where an unauthorized release from a UST occurred (Definition 3).
